

NOTICE

1. The Hon'ble Delhi High Court has appointed the undersigned as an Administrator of IOA for verification/ preparation of the voters list and for drawing up a schedule of elections of IOA.
2. The forthcoming elections shall be conducted only through the mobile number of the Life members registered with the Aadhar. Vide notice dated 03rd April, 2024 the Life members were requested to submit their declaration with complete particulars including photograph, Aadhar number, mobile number registered with Aadhar, permanent address, present address, Post-Graduate qualification and National Medical Council Registration number on weblink between 05th April, 2024 – 12 Noon to 05th May, 2024 -11:59 PM and an Independent Agency – M/s Ernst and Young LLP were requested to verify the credentials and only those verified members shall be entitled to contest and cast their vote in the forthcoming elections.
3. Multiple requests have been received from various IOA members to extend the date of submission of the declaration by the IOA members. Vide notice dated 5th May, 2024, the Administrative Committee extended the deadline for submitting the application up to 15th May, 2024 - 11:59 PM. With respect to the aforesaid applications to be submitted by 15th May, 2024, the IOA members are permitted to rectify the defects/ deficiencies by 25th May, 2024 -11:59 PM and M/s Ernst and Young LLP have submitted the list of verified IOA members.
4. Further request has been received from various IOA members to extend the date for submission of the declaration by IOA members who could not submit their declaration by 15th May, 2024. Request has also been received to extend the timelines for verification of the pending declarations which could not be verified for reason or the other.
5. The Administrator Committee has considered these request and has decided as under :-

- (i) Life members of IOA who could not submit their declaration by 15th May, 2024, are given one more opportunity to submit their declaration between 7th June, 2024 -12:00 Noon to 16th June, 2024 -11:59 PM. M/s Ernst and Young shall verify the credentials and submit the report to the undersigned by 27th June, 2024.
 - (ii) With respect to the declarations submitted by Life members till 15th May, 2024, the status as on 25th May, 2024 is that 1056 IOA members have not yet been verified. M/s Ernst and Young have been instructed to complete the verification process these 1056 applications from 07th June, 2024 to 27th June, 2024.
 - (iii) The members whose application have not yet been verified or are partially verified, are requested to submit relevant details to Ernst and Young for which they would be receiving an exclusive link from M/s Ernst and Young.
6. The procedure for verification to be adopted by M/s Ernst and Young LLP has further updated so as to assist the IOA member in achieving the verification status without compromising the integrity of the process and IOA member data.
7. M/s Ernst and Young LLP shall submit the list of verified IOA members by 27th June, 2024.
8. This notice shall be published on the website of IOA. All the State Chapters of IOA are requested to publish this notice on their website and also circulate the same on the various groups to give wide publicity to this notice.
