1. Vide notice dated 06<sup>th</sup> June, 2024, Life members of IOA who could not submit their declaration by 15<sup>th</sup> May, 2024, were granted one more opportunity to submit their Declaration between 07<sup>th</sup> June, 2024 to 16<sup>th</sup> June, 2024 and M/s Ernst and Young were instructed to verify and submit the list of IOA verified members by 27<sup>th</sup> June, 2024.
2. 7,058 Life members have submitted their declaration till 16<sup>th</sup> June, 2024 - 11:59 PM out of which 6,550 Life members have been verified till 22<sup>nd</sup> June, 2024. However, 508 members are still in the category of '*partially verified*' or '*not verified*' for reasons stated in the "*list of IOA not verified and partially verified members*" published on the website of the IOA.
