- [v] Dr. Swapnil Keney suggested that the voted member list should not be made public.
- [vi] Dr. NJ Karne supported the online voting system to be better than offline voting. He suggested the verification by the state chapter linking through Aadhar.
- [vii] Dr. Raju KP suggested the responsibility of verification to be given to state president and secretary.

- [iii] Dr. B. Shivashankar suggested that the verification of the data should be only by mobile number linked with Aadhar card and by only one IP Address.
- [iv] Dr. P. V. Vijayaraghavan agreed with all above stated suggestion of Dr. L. Prakash.
- [v] Dr. Rajesh Gupta suggested that mobile number linked with Aadhar cardbe used for verification. He also suggested use of physical ballot, if possible.
- [vi] Dr. A.N. Mukherjee suggested that dead members should be removed from members list.
- [vii] Dr. Sanjeev Awasthy suggested that the voted member list should not be made public.
- [viii] Dr. Sameer Agarwal suggested that voter list should be published on the IOA website for the members information so that everyone can cross-verify.
- [ix] Dr. Swapnil Keney also suggested that voted member list should not be published.
- [x] Dr. Harpal Singh Selhi suggested elections be conducted by paper/physical ballot.
- [xi] Dr. Navin Thakkar suggested that Aadhar verification should be introduced since the same was passed by the GBM in the IOACON, 2022 at Amritsar.
- [xii] Dr. Karun Jain also suggested verification through Aadhar.
- [xiii] Dr. Rajeev Naik suggested that there should be a NOTA column for members, if members do not want to vote for a particular candidate.
- [xiv] Dr. Uttam Garg suggested live photo of the member should be recorded at the time of voting through usage of digital flat form.
- [xv] Dr. Atul Srivastava suggested that Govardhan committee should be

- disbanded, and the same task should be entrusted to the Administrative Committee.
- [xvi] Dr. P.N. Vasudevan suggested that there should not be any objection to sharing of Aadhar card and mobile number. He further stated that the hotels check the Aadhar Card at the time of checksin.
- [xvii] Dr. Rajeev Raman suggested that face identification should be done through a government agency.
- [xviii] Dr. Mainsh Dhawan suggested that there should be a third-party audit by a government agency. He also suggested that mirroring of voting to be done.
- [xix] Dr. Raviraj Shinde suggested some State Chapters may be interested parties and so verification of members should be done independent of these state chapters.

- 4. The Foreign Fellowships have benefitted about 10 Life members who have been our ambassadors overseas. In the year we have received 135 applications for the fellowship 2023. Dr. Vinod Kumar has not availed due to some unforeseen reason and will again apply for the fellowship.
- 5. IOACON 2022 Amritsar in November-December 2022 was attended by more than 5000 delegates and was appreciated by most for both the academic scientific content and hospitality.
- 6. The Bone & Joint Week (1st to 6th August 2023) under the supervision of the CSRC Committee worked on the theme of "Each ONE, Train ONE, Save ONE". It created an ASIA RECORD by "Basic Life Support (BLS) training to maximum people PAN-INDIA in one single day". This is notified & awarded in the ASIA BOOK OF RECORDS.
- 7. The Indian Journal of Orthopaedics (IJO) maintained its high standards and came out with 12 issues. There are three year books under process of completion due for release soon.
- 8. The Office Bearers of the IOA actively participated in most State & Zonal Conferences. Most overseas academic invitations were attended based on reciprocity with the International Associations.
- 9. The PG Training Program saw a huge boost with activities being supported all over the country. Events were held at 8 institutions by the IOA in collaboration with local teaching institutions and its committee members.

- 10. Cadaveric Courses for hands on training were held at Himalayan Medical College Centers, Dehradun, Uttarakhand.
- 11. Aadhar Update was completed for about 3000 life members of the IOA through IOA website. We need some more perseverance and commitment for the same.
- 12. The Cover You Insurance scheme has received a good response and almost 1200 Life members have subscribed to the same from the different states of India.
- 13. As per the High Court of Delhi order dated 20th October 2023, Retd. Justice J R Midha has been appointed as the Administrator of the IOA. He would investigate the IOA Voters List issues, conduction of IOA Elections 2023 & oversee the smooth functioning of IOACON 2023 Lucknow. Justice J R Midha has formed a three-member Administrative Committee including Dr Rajesh Malhotra (Chair), Dr Anil K Jain, Dr M Shantharam Shetty to liaise with him and conduct the affairs of the IOA and Mr. Ramesh C. Pandey, CAO, IOA will also be the part of this committee to look after the work of IOA with Administrative committee under their directions. Justice J R Midha would be Chairing the Executive Committee Meeting of the IOA scheduled for 13th December 2023 & the General Body Meeting scheduled for 17th December 2023 to be held at IOACON 2023 Lucknow.
- 14. IOACON 2023 Lucknow is being held at the Ekana Sports Complex from 13th to 17th December 2023. It is expecting an attendance more than 5000 delegates. It has international faculties including Presidents of National & International Association from 10 countries. The IOA has reciprocal academic relations with all these associations and encourages collaboration for scientific & educational activities.

October: Science and Medicine in Cricket


November: Ethics in Orthopaedics

**IOA Registry**: After 3 years of deliberations, the IOA registry is now live now for making entries. The link for making entries is : <a href="https://ioa-forms.vercel.app/">https://ioa-forms.vercel.app/</a>

There are 5 focus areas in the registry as of now, which are—Giant cell tumor, Knee arthroplasty, Open Fractures, Hip arthroplasty and osteoporotic hip fractures.

**IOA Osteoporosis Medical Care Guidelines:** The Osteoporosis medical care guidelines were made and published as a special supplement of IJO. As discussed earlier for better dissemination of this knowledge hard copies will be printed and distributed to members. Educational funds would be encouraged from industry to support this cause. The Delphi survey inputs are still under development and would be published in IJO coming year.

**IOA Cadever Courses:** Four IOA cadaver courses were conducted under the Aegis of the surgical skill committee headed by Dr.Ram Chaddha and Dr.VD Chauhan at HIMS Jolly Grant Dehradun. The courses were on Knee arthroplasty, Hip arthroplasty, Acetabular fractures and Knee preservation. The main focus of these courses was three hour hands on for each delegate and two delegates on one body supervised by one faculty. All the courses were accredited for CME points by Uttaranchal Medical Council. The courses were supported by industry education fund and delegate fee. The courses did not cost anything to the association. It is proposed to continue these courses in the coming year.

**IOA Hip Score:** There has been a need to develop scores for our Indian circumstances. The IOA hip score development was initiated last year. It was a modification of the Harris Hip score, incorporating changes to our needs. The modified score now needs to be validated as a multicentric study.


