EIGHTH REPORT OF THE ADMINISTRATOR

1. Vide Order dated 04th September, 2024, this Hon'ble Court extended the time period for conducting the elections of IOA up to 20th October, 2024 and to submit the Report before this Court before 25th October, 2024.

2. In compliance with the directions issued by this Hon'ble Court, the undersigned conducted the elections of IOA from 05th October, 2024 to 15th October, 2024 through CDSL Limited. The result of the elections were declared by the Administrative Committee on 15th October, 2024 at 05:00 PM. The result of the Elections is as under:-

3. Two candidates for the post of State Representatives of Karnataka and Odissa are elected unopposed.
4. The Final Result of the IOA Elections, 2023 is as under:-
 - 4.1. ***Vice President*** - Dr. Navin N. Thakkar
 - 4.2. ***Secretary General*** - Dr. Rajeev Raman
 - 4.3. ***State Representative from Rajasthan*** - Dr. Deepak Chaudhary
 - 4.4. ***Successful Bidder for IOACON, 2025*** - North East Region Orthopaedic Surgeons Association (NEROSA)
 - 4.5. ***State Representative from Karnataka*** - Dr. Bharath Raju G (Elected Un-opposed)
 - 4.6. ***State Representative from Odisha*** - Dr. Biswajit Sahu (Elected Un-opposed)
5. As per the constitution of IOA, the Vice-President becomes President-Elect in the next year and President in the subsequent year and thereafter, Past-President for next two terms of the Executive Committee.

6. Vide judgment dated 20th October, 2023, this Hon'ble Court held that *there have been serious and material irregularities in the conduct of IOA elections 2020* and therefore the President and President-Elect were not permitted to discharge their official functions. The third report of the undersigned dated 14th February, 2024 is as under:

“B. PLAINTIFF REPRESENTATIONS

7. On 10th December, 2023, the Plaintiffs filed a representation in which they prayed that Dr. Ram Chadha and Dr. Anup Agarwal, should not be permitted to hold their respective posts; and secondly, Dr. Shanta Ram Shetty and Dr. A.K. Jain be removed from the Administrative Committee constituted by the undersigned.

8. Vide order dated 14th December, 2023, this Hon'ble Court directed the undersigned to consider the plaintiff's representation as per law. The relevant portion of the said order is reproduced hereunder:

“I.A. No. 24983/2023

1. During the course of arguments, it transpires that the applicant has submitted a representation to learned Administrator, seeking the same relief which has been sought in the present application.

2. Accordingly, this application is disposed of with a request to learned Administrator to consider the aforesaid representation in accordance with law.”

9. The Plaintiff's representation was taken up by virtual hearing by the undersigned on 07th January, 2024. The hearing was attended by the plaintiffs and other members of IOA and the next date, as per the convenience of all the attendees, was fixed for 27th January, 2024.

10. On 14th January, 2024, the Plaintiffs filed a second representation praying that the Voted Members List of 2021 and 2022 Elections be furnished to them.

11. The aforesaid representations were taken up by virtual hearing on 27th January, 2024 and 08th February, 2024, which were attended by the Plaintiffs and other members of the IOA who made the request for a link of hearing.

12. The plaintiff's first representation is on various grounds inter-alia IOA Election process of 2020 was declared to be vitiated as observed in para 64 of the order dated 20th October, 2023 and therefore, all the office bearers

who assumed the office were rendered ineligible to hold their respective offices; subsequent to the appointment of the Administrator, none of the members of the Executive Committee was entitled to hold any office of IOA; Dr. Anil K. Jain and Dr. Shantaram Shetty were observers in the IOA 2020 Elections and they supported Dr. Ramesh K. Sen and stated that IOA 2020 Elections were conducted transparently but changed their stand after the registration of the FIR No.25 of 2021 against Dr. Ramesh K. Sen. Dr. Anil K. Jain took a new stand that he could not perform the role of the Observer in vendor selection as he was occupied with his own work. Similarly, Dr. Shantaram Shetty refused to give his statement and didn't co-operate with the investigation. Reference is made to paras 49, 50, 51, 52, 59 and 64 of the order dated 20th October, 2023, which are reproduced hereunder:

“49. This Court finds it difficult to turn a blind eye to the aspect of (i) dead persons having been included in the voters” list; (ii) votes being cast on behalf of dead persons; (iii) false/bogus votes being cast on behalf of persons who have confirmed during police investigation that they actually never cast their votes.
50. There is merit in the contention of learned counsel for the plaintiffs that the anomaly/ example (of Late Dr. A. K. Gupta) cited in the application is symptomatic of a much deeper rot inasmuch as Late Dr. A. K. Gupta had been a pre-eminent member of the IOA and his discrepant inclusion in the voters list was therefore self-apparent and was detected on a mere cursory examination. Also, it is inexplicable as to how a mobile number and email was assigned to Late Dr. A. K. Gupta, through which an OTP was generated, enabling casting of a vote in the name of Late Dr. A. K. Gupta. The same is only illustrative of the nature and extent of the malaise, and serves to underscore the complete lack of integrity of the voters” list.

51. In the above context, order dated 07.07.2023 was passed to require the defendant No.1 and 7 to explain as to apparent casting of vote by the aforesaid voter i.e. Dr. A. K. Gupta.

52. In the affidavit filed on behalf of defendant No.1, pursuant to the aforesaid order dated 07.07.2023, the defendant No.1, has proceeded to disclose the names of the candidate/s in whose favour vote/s was cast on

behalf of Late Dr. A. K. Gupta. It is sought to be emphasised that for the post of secretary, a vote has been cast on behalf of Late Dr. A. K. Gupta in favour of the plaintiff No.2 (who was one of the candidate for the post of Secretary in the IOA elections held in November 2020). The same submission has been repeatedly made during the course of arguments, apparently to make the point that the plaintiff/s have not been prejudiced on account of the vote cast on behalf of Late Dr. A. K. Gupta.

xxx xxx xxx

59. In the facts and circumstances of the present case, all the above aspects viz. inclusion of dead person/s in the voting list; votes having been cast by such dead person/s; bogus votes having been cast on behalf of certain persons as noticed in the chargesheet; the voting pattern of the individual voters being subject to "selective disclosure" by the defendant No.1 in these proceedings and/or during the process of investigation in the FIR and/ or proceedings before the trial Court, have reduced the impugned election/s conducted in November, 2020, to a complete mockery.

xxx xxx xxx

64. Given the serious irregularities that ex-facie vitiate the elections held in November 2020, and given that the said elections have had a cascading effect as regards the constitution of the Executive Committee of the IOA, it would be appropriate to appoint an Administrator to conduct affairs of the defendant no.7. Such a course is imperative to ensure that the affairs of defendant no. 7 are put in order, and particularly to ensure that appropriate steps are taken to ensure the authenticity of the voters" list and setting up of robust electoral mechanism/s, in view of the upcoming elections scheduled to be held in November, 2023."

(Emphasis Supplied)

13. Dr. Ram Chaddha opposed the plaintiff's representation on various grounds inter-alia that 2022 Elections of IOA was not under challenge in CS (OS) 414 of 2020; he was not a part of conducting of the Election of the IOA – 2020; he is not a party to the Court proceedings; he was elected as IOA – Vice-President in the IOA Elections – 2021 conducted under the supervision of Retd. High Court Judge as Observer and was declared elected by a clear

margin; he stepped down as the Election Officer for IOA Elections – 2022 on 02nd November 2022 for personal reasons; Mr. Nikhil Mittal, the vendor appointed to update the IOA Life-Membership Data (June/July 2022) accepted in writing and took full responsibility for the unintentional error and tendered an unconditional apology for his technical error. This error had led to the inclusion of 621 gobile.com email addresses in the Life-Membership List submitted to IOA on 16th July 2022. He has further submitted that these 621 erroneous Email Addresses were not part of the final Voters list used in the IOA Elections 2022. The response of Dr. Ram Chaddha is annexed hereto as Annexure-C (COLLY).

14. The plaintiffs have filed their rebuttal submissions to the response made Dr. Ram Chaddha inter-alia he benefited and got elected from the same voters list; 2021 Elections of IOA were conducted on the same voter list as that of 2020 and Dr. Ram Chaddha had not given any explanation as to how fictitious members name got included in the IOA Voters List.

15. Dr. Anup Agrawal opposed the representations on various grounds inter-alia that he was duly declared elected as Vice President of IOA through IOA elections held in November 2022 under the observation of a Retired Judge and he was not part of 2020 Elections; one of the contestants Dr. Ajit Shinde filed a Civil Suit CS (OS) 804/2022 which is sub-judice before Delhi High Court but no stay has been granted. The response of Dr. Anup Agarwal is annexed hereto as Annexure-D.

DISCUSSION

16. In the Third Meeting dated 20th November, 2023, the undersigned observed that the office bearers of the Central Committee of the IOA cannot discharge their functions as office bearers after the appointment of the Administrator. However, this direction was partially modified in the Second Report to the extent that the seven office bearers of IOA were permitted to hold their official position but they shall discharge their official functions only under the supervision/directions of the Administrator.

17. Para 6 of the minutes of the Third Meeting was modified in the Second Report only to ensure successful completion of IOACON-2023 by permitting some office bearers of the Central Committee of the IOA to discharge their official functions under the supervision/directions of the undersigned. The above decision was necessary to

ensure a successful IOACON-2023 and therefore, it was clearly recorded that seven office bearers of the Central Committee of the IOA will discharge their official functions only under the supervision/ directions and not independently.

18. After completion of IOACON-2023, the undersigned has not permitted any office bearer to discharge any official function, except that Dr. Sandeep Kumar, Treasurer and Dr. Pardeep Bageja, Joint Secretary are permitted to sign the cheques of IOA, which is necessary and should be permitted to continue. Except the said office bearers having limited function, the undersigned is not assigning any official function to the office bearers of IOA.”

7. The IOA Elections for the year 2022 are subject matter of the Civil Suit bearing CS (OS) 804 of 2022 titled ‘*Dr Ajit Annasaheb Shinde v. Indian Orthopaedic Association & Ors.*’ pending before the Hon’ble Delhi High Court. In IOA Elections for the year 2022, Dr. Ram Chaddha was declared as the President and Dr. Anup Aggarwal was declared as the President-Elect. Dr. Ajit Annasaheb Shinde who contested for the post of Vice President but lost by a margin of 1 vote, is the plaintiff in the said suit. The said suit was listed before the co-ordinate bench of this Hon’ble Court on 23rd October, 2024, where in the fresh interim application filed by the plaintiff bearing no. I.A. 41586/2024 was listed in which the plaintiff has sought the following prayer:

(a) declare and hold that IOA Elections 2022 was rigged and the candidature of Dr. Anup Agrawal as cancelled in respect of IOA Election 2022 and further debar him from contesting any IOA Election for next five years;

8. The Hon’ble Court has issued notice on the aforesaid application to the defendant no.2, Dr. Anup Agrawal, and granted

time to file the reply and next date in the said case is next listed on 02nd December, 2024.

9. The undersigned has received multiple representations that the charge be handed to the elected body of IOA in Annual GBM only. In view of the successful completion of IOA Election 2023, the Administrator is handing over the charge to the newly elected Secretary General and Vice-President (*the Vice-President shall be officiating as the President in view of the disqualification of the President and President-Elect of the IOA*), subject to the further orders of this Hon'ble Court and subject to the orders in I.A. 41586/2024 in CS (OS) 804 of 2022.

10. The undersigned had also received multiple representations that the Govardhan Committee Report should be supplied to the IOA members. Copy of the representations received are annexure to this report as **Annexure-A (Colly)**. With respect to, Govardhan Committee Report the undersigned already submitted in its third report dated 14th February, 2024 as under:

“24. On 17th March, 2023, Dr. R.H. Govardhan submitted the Enquiry Committee Report; Analysis of Voter's list and Voted Members list of 2021 and 2022; and Interim Analysis of Voted Members list of 2021. The undersigned has examined all the aforesaid three reports. Dr. Govardhan in his report has opined that further analysis is required by computer experts. The relevant portion is reproduced hereunder:-

“There was discrepancy of 380 votes between data analysis and the result announced by Dr. Atul Shrivastava.!! This requires further analysis with computer experts”.

25. In the Interim Report of Analysis of Voter's list and Voted Members list of 2021 and 2022, Dr. Govardhan states that “it will require some more time for further analysis to submit interim for 2021 and 2022 lists”.

26. The undersigned is of the view that the Forensic Audit of all the three elections namely 2020, 2021 and 2022 elections are necessary. The undersigned is submitting all

the three reports of Dr. R.H. Govardhan Committee in a sealed cover for consideration by this Hon'ble Court as to whether the said reports be circulated to the IOA Members at this stage or after the Forensic Audit Report.”

11. In the its Fifth Report dated 02nd July, 2024, the undersigned sought the direction the Organizing Secretary - IOACON, 2023 to furnish the accounts to the Auditor but the same had not been provided to the IOA office. The relevant portion of the report is as under:

“Audit of IOACON, 2023 Accounts

*12. This Hon'ble Court directed the undersigned to ensure successful completion of IOACON, 2023. In the third meeting convened on 20th November, 2023, it was decided that IOACON, 2023 accounts shall be audited by an Auditor appointed by the undersigned. The undersigned appointed an Auditor to audit the IOACON, 2023 accounts on 22nd April, 2024. The Organizing Secretary (sic) - IOACON, 2023 was directed handover the accounts to the Auditor vide email dated 22nd April, 2024. However, the accounts have not yet been handed over and therefore, directions being are sought from this Hon'ble Court. Copy of the emails dated 22nd April, 2024 are attached hereto as **Annexure – G (Colly).**”*

13. Vide email dated 22nd October, 2024, the vendor for verification of the Voters list i.e. Ernst & Young LLP has informed the undersigned the data collected by them for the purpose of the verification shall be handed over in the coming week. Ernst & Young LLP has informed the following:

“In reference to our handover of data, please find below the list of information/documents that will be handed over:

- 1. We will be issuing the final report, which will include a transmittal letter (attached). The content of the report will be the same as what was shared earlier, dated 30 June 2024, along with a supplement to the report dated 18 Aug 2024.*

2. *For the verified members, we will be providing annexures in Excel format in a password-protected format, which will contain lists of verified, not verified, and partially verified members, along with one consolidated sheet containing all the required information for the verified members.*
3. *For the partially verified members, we will be sharing a consolidated file that will include all required information except for NMC, in excel format in a password-protected format. For the not verified members, we will be sharing all the information submitted by the members in the verification form.*
4. *We will provide a hard drive that will contain the verified, partially verified, and not verified members' LM-wise folders, which will include unprotected copies of Aadhaar, copies of M-Aadhaar, NMC screenshots, and videos/ face snip. The access to the folder will be password-protected.*
5. *The details as it was submitted by the members including any retakes in excel format , will be handover in a password-protected format.*

To complete the handover process, the chain of custody (attached) will be signed at the time of handover, which will contain the Index and details of the documents in the hard drive. The password for accessing all the excel files and folder will be sent via a separate email.

We will maintain backups of all documents for the subsequent six months, after which they will be permanently deleted.

14. The undersigned of the view that the said data should be handed over to the present Chief Administrative Officer of the IOA under the supervision of the newly elected members i.e. the Vice President and Secretary General.

DIRECTIONS SOUGHT


15. In view of the above, the undersigned seeks following directions:

- A. Take on record that the Administrator is handing over the charge of the IOA to the newly elected Secretary General

and Vice-President, (*the Vice-President shall be officiating as the President in view of the disqualification of the President and President-Elect of the IOA*), subject to the further orders of this Hon'ble Court and subject to the orders in I.A. 41586/2024 in CS (OS) 804 of 2022.

- B.** Pass appropriate directions with respect to Govardhan Committee Report;
- C.** Direct the Organizing Secretary - IOACON, 2023 to furnish the accounts to the Auditor;
- D.** Any other directions for the undersigned as this deem fit.

Respected learned Administrator of IOA,

Thank you, very much for guiding the IOA in its day to day affairs for almost a year as an administrator.

You have been transparent in conducting the elections without any hitch. The members of IOA are thankful for the help rendered in purifying the association and bringing transparency.

Thanks very much for going to Honorable Justice Sachin Datta's court to get the voted members list of 2020, 2021 and 2022 when the Enquiry Committee was finding all sorts of difficulties in procuring the voted members list. The committee members are very much thankful to You for the timely help rendered before the EC meeting held at Lucknow on 13.12.2023. This helped me a lot to analyse the data and find out the discrepancies, above all vote cast against the deceased members during elections held in 2021 and 2022.

One vote cast against Dr A K Gupta LM No 00236 (one of the past presidents of IOA, founder President of UP orthopaedic Association who passed away in the year 2007) resulted in a verdict in the court of Justice Sachin Datta. Then IOA President Dr Atul Shrivastava lost his post and it was a historical moment that You were appointed as an administrator of IOA.

Later at the insistent request of many members of IOA, You were fair enough to publish the voted members list in the IOA web site.

There were many computer suave members who analysed the results and wrote to you mails. Sir, 4 Past Presidents of IOA, Chairman of grievances Committee of 2022 and myself Past Secretary of IOA have spent almost 6 months in conducting the enquiry and unearthing irregularities in offline updation of the IOA membership list. There was criminal conspiracy to include email ids and phone nos of inactive and deceased members of IOA so that it can be utilized during the election process. It is known fact that only Dr Anup Aggarwal had the IOA members list with manufactured, spurious email id namely gobile.com. I have submitted the entire report to you on the last day of IOACON Lucknow on 17th of December 2022. Unfortunately I was not allowed to present the report for reasons known to You only sir. I am sure You and Your assistants have gone through the entire report.

I am just adding the concluding remarks of the report here

Analysis of the answers and questions with available evidences suggest

1. Mr Nikhil Mittal and his team have done deliberate tampering of the IOA membership updation. They have inserted email ids and phone nos at their will. The targeted members were mostly inactive members of IOA who do not bother to update their mail ids and phone nos. It is pertinent to point out here that an external agency may not know this intricate details. They were only the pawns and who actually controlled this updation can only come out by police enquiry. Most of

the committee members felt that FIR should be registered against him to get the truth.

2. Dr Anup Agarwal brought out the fact that UP members who have email ids only were eliminated while other state members with email ids alone are in the voters list without realising that what he was bringing out .

Dr Shivashankar Past president IOA in the EC meeting held on 30.04.23 pointed out that the list given to Dr Ram Chaddha did not contain gobile.com mail id whereas list submitted by Dr Ram Chaddha had plenty of them. There is no need of a Sherlock Holmes to detect what went wrong and where.

Dr Anup Agarwal list of UP deleted members contained gobile ids only. During the zoom meeting we have shown him the similarities of his list and list provided by Dr Ram Chaddha to IOA secretariat in terms of fonts descending order of the list It was unfortunate that till the end he did not tell us the source of this list

3. Dr Ram Chaddha took full responsibility of the updation of IOA members' list and he was authorised to do so by CEC
4. He was asked to provide three vendors' quotations and the budget to decide about the vendor by CEC but it appears that he kept the CEC out of the loop in decision making. There were no documents shown to the committee to substantiate that vendor selection was a collective decision of the CEC
5. The vendor has submitted the updated list on 04.07.22 and bill on 07.7.22 to Dr Ram Chaddha. Dr Ram submitted the updated list on 16.07.22 During this interim period the data was with him for scrutiny. It is a fact that 90 members emails have been changed from gobile to other email ids like gmail, rediffmail, Hotmail etc. Who made the change ? we have no direct answer.
6. Having obtained the sanction from CEC on 30th May Dr Ram has flown to Canada on 02.07.22 on the promise that he will supervise. It is surprising to the committee that when he knows about the planned trip why to take such large responsibility?
7. There is no documentary evidence to suggest that he requested Dr Navin and Dr Jethwa to supervise the updation
8. The tampering of the members list may not have seen the light had Dr Anup Agarwal not written the mail on 22.10.22 complaining UP deleted members data.
9. This mail has been addressed to Dr Ram, Dr Sen and Dr Navin. So Dr Ram was aware that there is a problem.
10. On 31.10.22 Dr Ram pointed fingers to Dr Navin and Dr Jethwa for the tampering which they both denied.
11. Summing up Dr Ram is supposed to own up all responsibility of whatever has happened because of the agency he appointed. It is his moral responsibility
12. In the beginning of the reply Dr Ram wrote:

It seems that the present email has been sent to me by the respected enquiry committee without being fully aware of the facts and circumstances of the present case. With all due

respect to all the senior and respected members of the Indian Orthopaedic Association (IOA), it further seems that the present enquiry has been set up against me as an afterthought with an ulterior motive and mala fide intention.

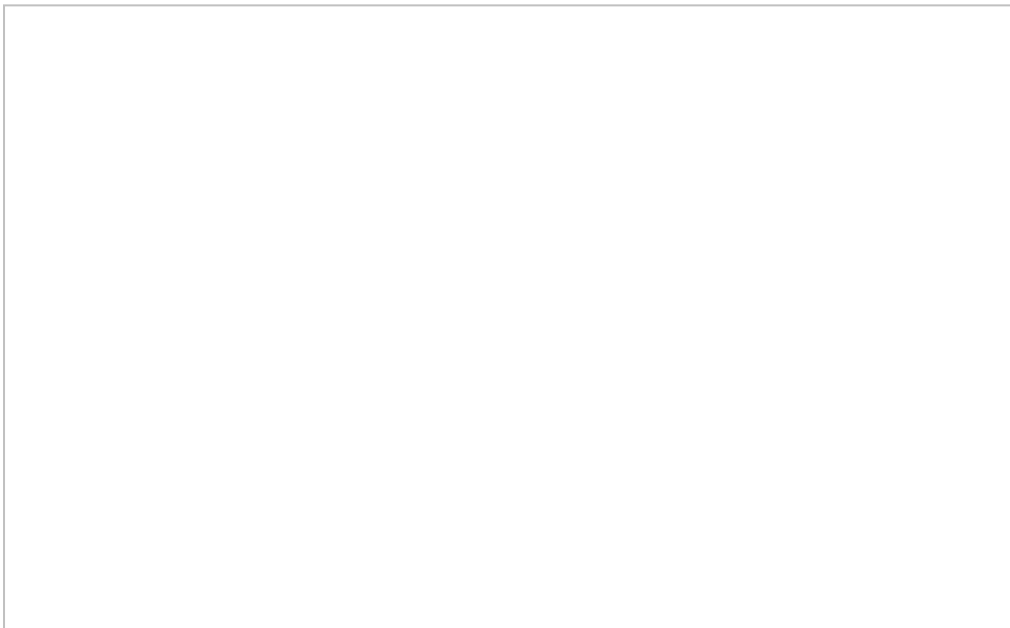

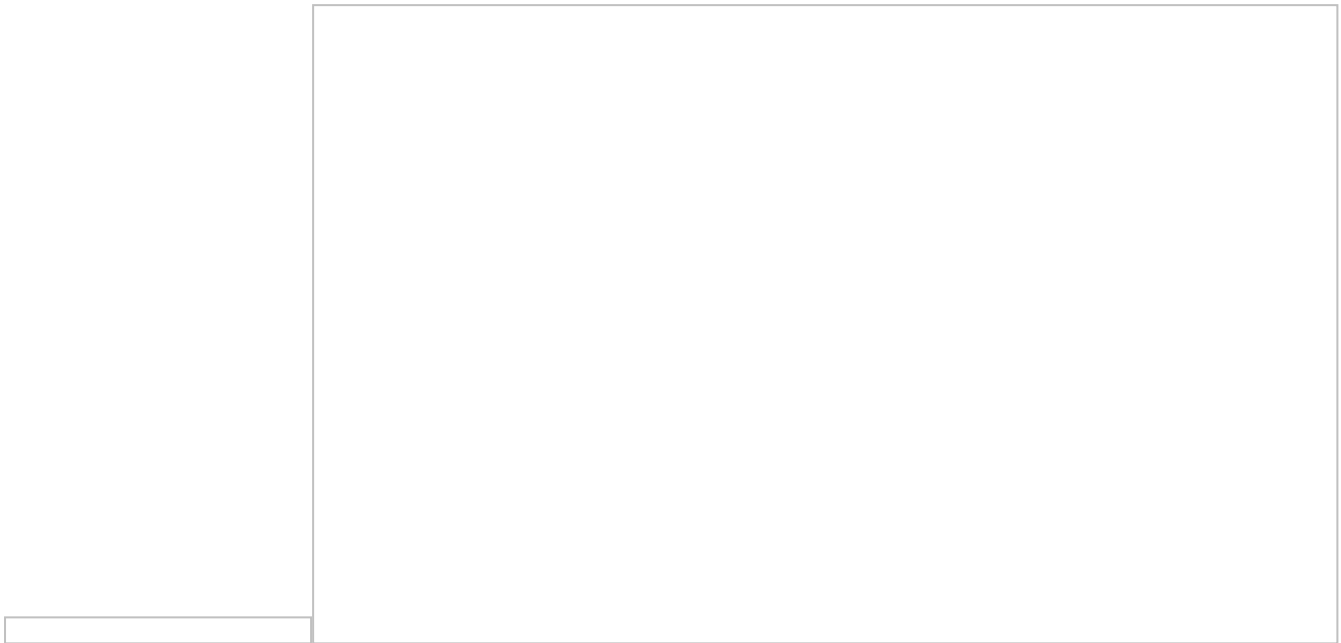
Two important discrepancies are –
