

## **Online Zoom meeting in continuation of Agenda of Physical Executive Committee Meeting of 30-4-2023 -Minutes of Proceedings**

**Venue : Zoom Platform Online . Date : 07/05/2023. Time 9.30 AM Onwards**

Dr Navin Thakkar took permission of chair to start further proceedings of agenda of 30-4-2023 and remaining discussion . Dr Thakkar welcomed all EC Members and informed house that we will start this EC meeting Online starting from Academic Committee Report by Dr Vivek Trikha and Team as decided on 30-4-2023.

### **Academic Committee report – Dr Vivek Trikha and Team**

Dr Trikha started with thanks to his team members and advisors and Whole EC for giving responsibility of this task . He informed house about short term and long term goals and strategies in **3 verticals**.

1. **IOA Academic Calendar** : he briefed that we will plan activities by 5-6 Major Academic committees spaced apart spread in different months and will discuss in details. Smaller committee may have their niche area for working and gave example of Knee preservation academic committee
2. **IOA Talent pool** : Idea as discussed with secretary general and discussed with It committee to make google kit or input on IOA website to have young talent of pool and academic contributors , not limited to be a faculty , involving IOA office , IOA website , CSRC and IOACON organisers
3. **IOA Training ProgRam** : Idea is to develop faculty training and improve self-development of Each IOA member . Other progRams will be Education reach out by webinars ,contribution from SARC countries, academic content development , collaboration with PG teaching committee for long term planning for competency enhancement of PGs and undergraduates , mentoring progRam of gold medal paper presenters by training them for how to do presentation. Dr Trikha requested all to involve academic cell in all academic activities and have coordination with academic cell. Dr Trikha made a food for thought and requested all committee to put one case or image on IOA website for discussion . He discussed need of teaching trainers also. Dr Trikha thanked whole EC for this opportunity and asked for suggestions if any. Dr Thakkar asked Dr Hooda to unmute all for discussion. Dr S S Jha sir congratulated Dr Trikha for great work. Dr Atul thanked Dr Trikha for nice roadmap and working hard and coordination with all committees and coming out with single presentation. Dr Jamal suggested to include academic cell chair in Central Organising Committee for making and suggesting academic progRam of IOACONS, This suggestion was passed . Dr Trikha started for individual committee report in alphabet of names . He invited Dr Sharma with his team to present report of Arthroplasty committee to present their report .

### **IOA Arthroplasty Committee -Dr Sharma and Team**

Dr Sharma asked Dr Trikha to go ahead reading report and agreed to give inputs when needed. Dr Trikha informed that Arthroplasty committee is working on 5

Dr Trikha informed house that Arthroplasty committee has executed some webinars and planned more webinars and regional arthroplasty meetings . Dr Sharma made inputs for collaboration in faculty pool and joint registry with ISHK and promised to work together for the benefits of young IOA members. He asked support from IOA for example issue of Bilateral Knee replacement and its legal issues .He suggested to form guidelines in combined consultation with IOA, IAA and ISHK which will be useful for members in court of law , government policies etc. Further he informed house that for Journal of IAA task is assigned to Dr Anup from Jaipur. Dr Sharma informed house that there are very good progRams by state arthroplasty societies which attended in West Bengal and Odisha.

Dr Atul Srivastava informed house that we have already a committee of registry and it is working hard for registry and earning of journal of IOA – IJO will be invested into IOA Registry .

- ◉ Meeting was attended by more than 80 delegates. It was very well received and appreciated by delegates.

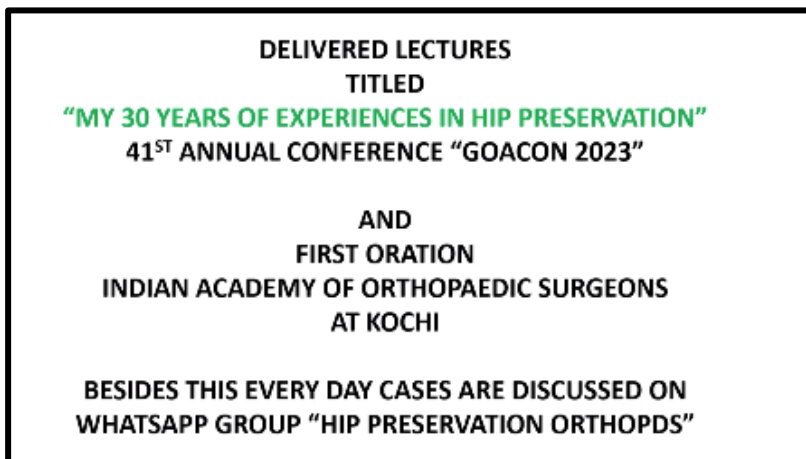

Dr Harpal suggested to include academic cell chair and editor of IJO to scientific committee of IOACON. Dr Thakkar said that Editor is already inbuilt in committee since I am working as Hon Sec and Dr Maini has given his inputs in all venue visits. Dr Trikha should be taken to take care of academic part input as many times IOA officers are busy in other work, where he

can give inputs . Dr Naresh Shetty pressed need of guidelines with the help of Dr Vivek Trikha . Dr Atul – President asked any more questions. Dr Ashish Gulia wanted to say something but audio was not clear due to low connectivity

IOA Talent Pool , IOA Academic Calendar are in pipeline and under documentations and discussion.

Daily updates are done by members every day. He requested all leaders and EC members to update at least their profiles first.

Dr Atul thanked for good work by Dr Jawahar Jethwasir

Dr Saggar wanted to say on behalf of Dr Ashish Gulia as he had bad network and suggested that they want to do webinars under umbrella of IOA so that all basics of Ortho Oncology can be reached to even PGS . Dr Atul said that he has received letter also and wanted EC to pass. Dr Thakkar said yes it should be passed as good academic activity , so passed.

## **Rebuttal of Dr Navin Thakkar for Dr Ram's presentation on 30-4-2023 meeting without any agenda**

Dr Navin Thakkar requested that he himself wants to present rebuttal of facts and evidences for Dr Ram's presentation because he was not knowing that agenda of Dr Ram going to speak and present a long prepared presentation and as he was not ready and not allowed much time as it was late . He shared his screen. Dr Atul – President said that let the other agenda be completed .

Dr Thakkar said No No sir , allow me . Dr Atul said what is No.... No...? Dr Thakkar again requested that allow us as you allowed Dr Ram without agenda and we were not knowing this and so not having presentation ready at that time.

Dr Thakkar started reading the first slide and requested EC humbly to allow him and note down if any questions.

Dr Atul objected that you are putting directly on me , so tell it again . Dr Thakkar told it again that “you as a chair had not allowed me to rebut fully , so allow now to present .” Dr Atul asked “when I said you “No” on 30-4-2023 meeting ?” Dr Thakkar said “ Yes you had not allowed us fully on that Day “ Dr Jawahar Jethwasaid “ Yes “ Dr Atul asked Dr Jawahar Jethwathat you were there . Dr Jawahar Jethwasaid “ Very short time was allowed and I am also hurt and we must declare many points to make it clear” Dr Thakkar said “ Dr Ram also has to admit our hurt” Dr Atul said “ That is true but what you said , you are giving direct assault to me as President “ Dr Thakkar said “ I am not doing any assault but requesting” . Dr Jawahar said not enough time was given , that is the only problem . Dr Atul said “ Ok Go ahead “

Dr Thakkar said Ok and started with Title :

Dr Thakkar said “ **Facts and evidences speaks** something else, so not to misguide the august EC by creating a Story. One story was created on 30-4-2023 meeting ,but we want to put facts and evidences and not the story “

**Dr Thakkar said further with slide 2** “ Dr Chaddha said while reading his paper in speech that he was keen to update the data at the time of IOACON2021 at GOA . he contacted us at that time , but we requested him to put his proposal in EC . We had a physical EC on 1<sup>st</sup> may 2022 , where he was advised to put his proposal in EC , but somehow, he did not put his proposal of data update in that EC where he was declared as Election officer.

**Slide 2 :**

I was keen to make the IOA a robust body of academicians who should also express advocacy and work towards representation of the Orthopedic Surgeons in society, with the public, with the journalists, with the judiciary & with the Government of India. I genuinely felt that the IOA should involve a larger percentage of its members and move ahead. In my immediate circle of colleagues and on spreading the word, I realized that on one side there was lack of awareness or interest in a few members, while others had just incomplete data like mobile numbers / email addresses / other contact details which kept them away. Having conducted IOACON 2021, Goa as the Organizing Secretary, a lot of data for analysis was available considering many members & non-members attended.

**Physical EC meeting was held on 1-5-2022 . Dr Ram Chaddha was declared as Election officer by resolution. He did not spell about his wish to update data during this meeting .He had a wish to update data since December IOACON 2022 @ GOA.**

**Dr Thakkar screened further slide 3** and said” Then again Dr Ram asked it , so IT committee was ready with the website

**We called a meeting on 27-5-2022 with IT committee for feasibility and technicality of offline update as demanded by Dr Ram Chadha. IT committee chair Dr Jawahar Jethwa explained Dr Ram and Dr Sen in detail and gave his technical opinion and requirements of three extra columns in excel sheet to be filled by Dr Ram's agency. First Column of Who has contacted , Second Column when contacted and what is the change or update on third column. Remark should be made by Dr Ram Chaddha after verification and reverification by himself**

for online update , but Dr Ram wanted to do offline update. On 27-5-2022 with IT committee meeting was done with Dr Ramesh Sen and Dr Ram Chaddha for technicality and feasibility . We all know that this is the file given to Dr Ram Chaddha for update , expired members details were indicated in red bold letter . Right sir “

Dr Thakkar screened slide 4 and said :” Dr Ram said in his emotional speech , he was not “desperate”, others said he was “passionate”.

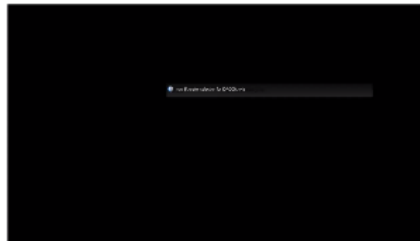

Dear CEC Members

As per instructions by Dr. Ramesh Sen –President –IOA and discussion done on zoom meeting of 27-5-2022 where IT committee presented details step by step on technicality and feasibility of Proposal made by Vice President and Election Officer Dr. Ram Chaddha to have his team to do a work of data update of IOA members, where Principally we all agreed to put details in CEC to pass this proposal and start this work without any delay. We all thank Dr. Ram Chaddha for taking this responsibility.

Details Discussed point-wise which to be passed in CEC:

1. To accept the latest database provided to the IOA House office by the old vendor – Mr. Deepak Singh as baseline database along with other tables of new ratified members etc.
2. From that database make an excel file of mandatory details of LM number, Name, Email ID, Mobile Number, Primarily affiliated state chapter, and extra fields where Team made by and working under Dr. Ram Chaddha to note details during their conversation with a member, etc.
3. Team headed by Dr. Ram Chaddha after scrutinizing data, will provide scrutinized data in multiple sheets to be uploaded/updated by the IOA office staff in Delhi on the new website of IOA, where on uploading each member will get an email message automatically about details updated and check for any entry error if any till cut off date of updating data for making an elections register of members.
4. Dr. Ram Chaddha –will provide details of the team and the IOA office will inform IOA members to cooperate with team members.
5. CEC will allow Dr. Ram Chaddha to do this work with his team and will pass the proposal with the budget.

**Team headed by Dr. Ram Chaddha after scrutinizing data, will provide scrutinized data in multiple sheets to be uploaded/updated by the IOA office staff in Delhi on the new website of IOA,**

that these are the principle decisions taken in technical feasibility meeting , Dr Ram screened this slide , but he has not shown or spoken that Team headed by Dr Ram Chaddha after scrutinizing the data , will provide scrutinized data in multiple sheets to be uploaded on website . You can see that it was decided that Dr Ram Chaddha will provide details of his team to IOA office and IOA office will inform members to co-operate , because members may feel a call asking their email id and mobile number as a spurious call with a spurious source. So ,we requested Dr Ram Chaddha to provide his team member’s name and mobile numbers , so that we can put in the mail to members according to his proposal of offline update.

**Dr Thakkar screened next slide 8** and said “ This is a slide of two videos where I need to run these videos , otherwise you will not know details and evidence.

Dr Ram Spoken in that CEC Meeting of 30-5-2022: “ It is going to be a fairly large election ( Dr Thakkar in Background : ONLY 12 Seconds) but not that large as next year election. So, I think we need to do our homework this year . Try and complete these 14444 data as completely as we can. With this I am hoping that in one month I shall be able to take personal interest in those 800 to 1200 , where there is NO Data available. I am taking that Responsibility of verifying and getting as many of those correctly. What I mean by correctly is ,I do not want that to be misused. Hence, I take the responsibility and I shall take a few people on the board who have access to these individuals. “

Dr Thakkar clicked [Second Rt side Video](#) on slide , where Dr Ramesh Sen -President IOA spoke “ I am just looking for it ,that let us be ready with the kind of manpower or a kind of an agreement with some company. It is my perception that we hire some company with its manpower, we can make it as a kind of arrangement with that company to provide the manpower to do this job , is that will be OK Dr Ram ?”

Dr Ram spoke “ Yes sir , we will look for. My mental idea was , we have about 15000 people to be approached , I am using 14444 , calling it 15000 . If I give an individual a thousand (1000) number to be done in a month , I have to get 15 people ( In Background Dr Sen said “ Thik Hain”) and that is my mental way of working out that I am going to give them a month and I am going to supervise each one of them with 1000 numbers with each . Of those 15000 numbers , I am telling you , I am taking the responsibility of almost 1200 myself , which is the one with NO DATA . The ones, that they are going to reach out are the people who have either of the Data available , something or other, phone number or email , that is where they are getting in , to get the other . Again, time interval between 1<sup>st</sup> August and 1<sup>st</sup> July is also going to be used by people to go and update the other part , their postal address , their subspecialty interest , everything and whatever is there , which has been created by our website. But these five (showing five fingers of hand ) points where we are working right now , because these five are critical for election , One Life membership number , second name, third one mobile number, fourth one email id ,and state “

Dr Aul- President and Chair **interrupted** and asked to conclude for discussion . Dr Thakkar requested to complete and continued showing on screen how on 9-6-2023 , he has forwarded the mail from member for update to Dr Ram Chaddha as per his instruction number 3 and said that he can show all mails , but showing one sample only to save time of EC.



He reiterated that all mails were transferred [- forwarded to Dr Ram Chaddha](#) to have single point of offline update from Dr Ram Chaddha as instructed because he was in sole charge of it and instructed us. These are evidences and all these mails must be there in Dr Ram Chaddha's mail Inbox and he must have transferred to Mr Nikhil Mittal from Canada . So Dr Ram was communicable and available to all to interact.



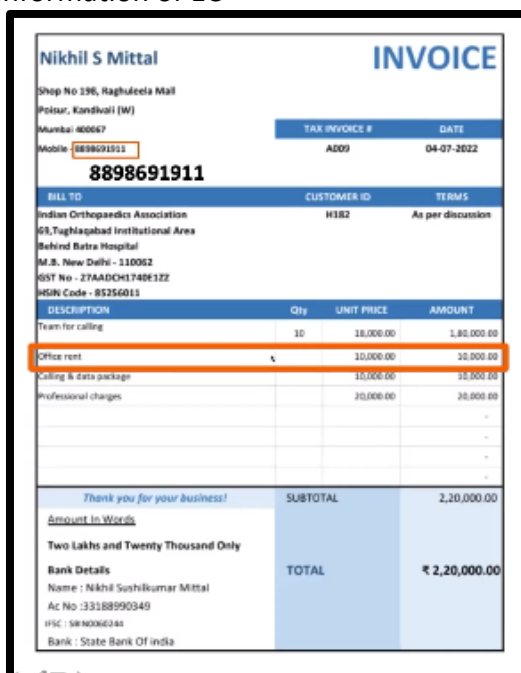

There is no official proposal from Dr Ram Chaddha or any MOU or Contract document given to IOA office. All trusted on him.*

So, Dr Ram Chaddha himself [received the invoice dated 4-7-2022 from Mr Nikhil Mittal](#) shows that vendor Mr Nikhil Mittal was reporting to Dr Ram Chaddha and Dr Ram Chaddha was having total control on him. Dr Ram Chaddha was actively in communication with Mr Nikhil Mittal. Dr Thakkar said that “ We cannot believe that Dr Ram Chaddha is not doing verification of data as per his punctuality and perfectness in nature. There was no official MOU or contract made available to IOA office from Dr Ram Chaddha or anyone. We all trusted fully on him. There was no reason to not trust him. Dr Thakkar screened next slide 23 with evidence and said “ On date 8<sup>th</sup> July 2022 I congratulated Dr Ram Chaddha for completing work with verifying data updated, as he declared that work is done and suggested to connect Dr Jawahar Jethwaas website is ready and Dr Sen has seen it. On 8<sup>th</sup> July 2022. He replied “ God bless you” Dr Ram chaddha declared this from Mumbai itself after Mr Nikhil Mittal gave him

[08/07/2022, 09:48] Dr Navin Thakkar Ahmedabad: Dear Dr Ram

Great News that data update is ready and scrutinised by you also as u wanted . I just done ring in morning and conveyed message to Dr Jawahar Jethwa - He was busy in surgery -but got message now from him that There was long 3 hours meeting on zoom with President Dr Ramesh Sen Sir and he suggested some changes day before yesterday and almost all changes are done and website is ready to launch with Sen sir’s all suggestions . He will ring you for data part

*On 8-7-2022 , Dr Ram declared from Mumbai that data update is ready and at the same time new website was also ready and we congratulated him for the scrutinizing the data by himself. He has not disowned his sole responsibility and continue to receive credit happily in all conversations and in IOA EC Meeting on 7-8-2022 , when this point discussed and further till 31-10-2022 EC meeting when [gobile.com](http://gobile.com) issue came from file sent by him in Gmail attachment*

Chaddha continued to receive credit of offline data update project till [gobile.com](http://gobile.com) surfaced on 31<sup>st</sup> October 2022 meeting . Till 31-10-2022 Dr Ram Chaddha was in full ownership of this offline data update project.

#### **Dr Thakkar further screened next slide 24 with evidence**

And said “ on 11-7-2022 and 12-7-2022 , this picture itself speaks the fact where Dr Ram Chaddha says “ I am sitting with Nikhil and IOA DATA “ Dr Thakkar said “ No body will believe that Dr Ram Chaddha was not in contact with vendor Mr Nikhil Mittal or he was not aware of it. He was very much involved inside his job and doing very well ”

Dr Thakkar screened next slide 25 with evidence and [clicked video in slide](#) and said “ On 12-7-2022 , there was IT committee meeting , where we asked him whether he has completed verification of data or not , when Dr Atul asked how we will do the election , just listen to this and Dr Thakkar clicked video in slide where Dr Sen said , next is election and it is a very important point . Dr Atul said “ Me yahi kah raha tha Jawahar Bhai ko , election kaise karaoge , pandra din bad notification of election ana hainh.” Dr Sen said “ exactly”. Dr Atul said “ I am asking Dr Jawahar Jethwa and our Secretary General Dr Navin Thakkar . Dr Thakkar replied “ Last time bhi ye situation thi , ab chronology aise set hogi , last year we updated last till 10-10-2021 as usual and finalised data around 12 October and was given to Dr Atul as election officer.

**12-7-2022.** Dr Chaddha was present in meeting when discussed about verified data from him, he has not denied or disowned the sole responsibility. Videoclip of IT committee meeting on 12-7-2022. Watch Carefully.



So as per norm we can do data update till 10-10-2022 this year . Our first step would be to get data from Dr Ram Chaddha , which he must have verified as he said that he will see personally where there is a doubt and securitize himself. We all are waiting for that and

likely to get within 4-5 days from Dr Ram Chaddha . Once we get that data from Dr Ram Chaddha , it will go to IOA office , Mr Ramesh Pandey . Mr Ramesh Pandey may have received few request from members online which is not contacted by Dr Ram Chaddha or his agency , he can verify that request . after that Mr Ramesh Pandey will upload it on website. Once uploaded on website we can allow log in to members to update online which is blocked now during offline update. Log is possible on website but not including data from Dr Ram Chaddha . If we allow now without data from Dr Ram Chaddha, it will overwrite on each other , then it will be difficult to know which one is latest, so let Dr Ram complete offline data project. We are waiting for data from Dr Ram Chaddha. Once that is uploaded on website , we allow log in, then members will do themselves data update online on website. We will give 2 months to member to do update themselves after we upload data from Dr Ram Chaddha and we will be able to do till cut-off date of 10-10-2022 .

This was the plan originally as planned in feasibility meeting and Dr Ram Chaddha was going to verify and scrutinise himself and was going to give verified data and that whatever updated data available from him was planned to upload on website for self-verification by members Online. On 12-7-2022 , we asked Dr Ram Chaddha to give verified data but he has not said any time that he has not verified and was fully owning the project of verifying and completing the data. It is fact that during this meeting on 12-7-2022 , Dr Ram Chaddha was at Mumbai and as he stated in message to Dr Jawahar Jethwa, He was sitting with Mr Nikhil and IOA DATA, that is the fact.

**Dr Thakkar screened next slide 28 with evidence and said “** This is letter from Dr Ram Chaddha on 16-7-2022 and Dr Ram Chaddha relied on this letter fully and argued and informed EC that he asked us to verify DATA , No .

**There was a first phase of Offline data update** project where Dr Ram Chaddha had taken personal responsibility to make his own team ,verify, scrutinize and supervise himself 15 team members and provide verified offline update IOA Data of members to IOA office . Yes ,after he provides whatever verified updated data to IOA Office to be filtered and put on website for further verification by members themselves online as self-verification in **second online phase of verified data update** till cut of date of 10-10-2022.

Now let us see what he writes , very peculiar he writes “ Dear Secretary General I am attaching ( so he was attaching ) the list ( means excel sheet attachment) with the responses based on interactive contact , via phone calls , via SMS, Via WhatsApp, via Email , and the cross references . So he was very much knowing that on what basis and by which tools he was working to collect the data a head of team controlling team of 15 people .

**So Dr Ram collected all these data and in that data all 711 gobile.com entries are product of these responses , we have to believe that. All entries were done on the basis of all these tools and responses as written by Dr Ram Chaddha and Dr Ram Chaddha was well informed about these tools for collection through it of data .** So here Dr Ram admits that he has supervised and collected data with the help of these tools with his team and verified data .Dr Ram says that further verification has to be done by putting data on website , That was the option and plan from the very beginning as discussed in feasibility

meeting , where Dr Jawahar Jethwawas ready to start Online update module but Dr Ram wanted Offline update project , that is why online update module was put on halt till that time Dr Ram completes offline data project.

**16-7-2022.** Dr Ram Sent file named "Data 15 July 2022 for Dr Ram Chaddha (1)(1) (1) (Recovered) (1).xlsx 2238K" as attachment in Gmail

***"Dear Secretary General Sir,***

***I am attaching the list of the IOA Life Members, with responses based on the interactive contact via phone calls, sms, Whatsapp, email and cross-references, gathered by the team till date over the past six weeks.***

***That means all 711 gobile.com entries were product of these responses and all entries were done on the basis of all these tools and Dr Ram Chaddha was well informed that all these tools are used and about log of all these tools and data collected through all tools***

***Dr Ram admits that he has supervised and collected data with his team with above tools known to him which he must have verified on his side as planned and promised by him on 30-5-2022 . He has not mentioned anywhere that he has not verified whatever he is submitting in excel file till 31-10-2022 Emergency meeting where gobile issue got revealed Dr Ram had put up the invoice for the efforts for verified data***

Dr Ram put up invoice of vendor for what ? For **efforts he made with his team for verified data and not unverified data** . We are still trusting Dr Ram Chaddha and we all trusted him fully , so when he submitted data on 16-7-2022 , I passed data immediately **within 3 minutes** to IT web committee as mentioned by Dr Ram Chaddha in his speech.

IT committee filtered data as predesign given to Dr Ram Chaddha that when there is any change , there should be a note in that column and that note will ONLY be considered. So any change has been done in email ID or mobile has to be noted in note column. And was implied that any change has to be noted .

**Dr Thakkar screened next slide 29 with evidence** and said

"But now on analysis many Email IDs are put and many mobile numbers are put , but note was empty and notes were wrong that we will see in excel sheet file.

Dr Thakkar shown a sample data of members which was given to Dr Ram Chaddha by IOA Office on 7<sup>th</sup> June 2022, Here all fields are empty and there is no gobile.com email id and file was given named as "New compiled data 7<sup>th</sup> June 2022 for Dr Ram Chaddha" These re the members where there was no DATA – no email , no mobile number and second one for comparison received from Dr Ram Chaddha on 16-7-2022 as email attachment . These are the findings after analysis done after 31-10-2022 episode of EC meeting , We were not knowing this or not suspected such thing.

**07-06-2022.** IOA Office Provided IOA data file to Dr Ram Chaddha by Gmail not containing any gobile.com entry. He must have communicated from CANADA to his team . So he was communicating and supervising his Team.FileName “New Compiled Data 7 June 2022 for Dr Ram Chaddha.xlsm”In this file there was no data of mobile and email of inactive members

compare two sheets with identical LM number in both. We had not analysed this before . We trusted Dr Ram Chaddha.

In his speech he said that only one data had a mistake of putting note as changed and shown as updated . data was put in many by team of Dr Ram Chaddha , but one can see that they have put gobile.com email id , mobile number , who contacted name, when contacted date and note as switched off . If mobile was switched off means no communication – no response , then how gobile.com was entered in email id. ? See another entry – invalid mobile number means no communication, no response , then how gobile.com was registered ? Another entry as unavailable – no communication – no response , then on what

basis gobile.com email id entered ? Se another entry wrong number as note but still there is gobile.com email id entered , on what basis ? Another note in note column -Number does not exist that means no response . On what basis gobile.com entry made . Another note is “expired” and yet email id of gobile .com entered , on which response , from where response ?

These two sheets are identical with same LM number data in both .

Another example of last entry , Dr Murali Sayana, Telangana, entry done by kinjal, on so and so date and note is already correct data , with gobile.com as email id , which was not there in 7-6-2022 list provided by IOA House to Dr Ram Chaddha. These are facts I need to show to all EC member. It is a matter of investigation by inquiry committee . Same thing can be highlighted in one excel sheet of identical data of 7-6-2022 file given to Dr Ram Chaddha by IOA office and Another of 16-7-2022 received by IOA office from Dr Ram Chaddha in mail as attachment. Dr Shiva said last Sunday that file given to Dr Ram Chaddha was not gobile.com , but file received from Dr Ram Chaddha had 621 gobile.com , so no need of sherlock homes to point out and he said some Latin word of judiciary , I do not remember but he spoke it .

Dr Ram did not informed EC members on that day of EC that he has not verified data for

which he took personal responsibility to verify and supervise where there is NO data – No Mobile , No Email of 800-1200 members.

**7-8-2022 On Line Zoom EC meeting with Dr Shiva's Objection**

IT Committee presented report with excel file supplied by Dr Ram Chaddha of 15 July data, where Dr Jawahar Jethwa shown column of update data with third column of note as verified update by agency headed by Dr Ram. He shown number of members updated around 500 plus by agency of Dr Ram Chaddha as per that third column . Dr Jawahar Jethwa asked EC to give permission to accept the data of 500 plus members updated by Dr Ram , to be uploaded on website for further verification by members

*Dr Ram did not informed EC at that time also that he has not verified data for which he took responsibility particularly for members not having mobile and email both*

Dr Thakkar clicked video of 7-8-2022 EC meeting

Dr Thakkar told a solution to write every member by email and Whatsapp that agency headed by Dr Ram Chaddha has updated your data offline ..... **Dr Atul Srivastava asked subtle change and not to write word agency and how it is updated ( SEE VIDEO )..... More details in Video and PDF file of minutes – Page 34-42 Agenda 14 IT committee report by Dr Jawahar Jethwa.**



**We All Together Fully Trusted On Dr Ram Chaddha and accepted whatever verified data Dr Ram submitted to IOA and filtered by IT Team With Objection from Dr Shiva**

Dr B Shivashankar –Past President objected it and comment by Dr Jawahar , Dr Thakkar and President Elect Dr Atul. [Just Listen it](#) . Dr Shiva said “ Instead of putting this data directly on website , what I suggest is you can ask all these members to register themselves on IOA website and do not accept this directly that is first thing and whatever data is updated by Dr Ram and I am happy that he has taken trouble to update it , but only about 500 people data has been updated, whether that is cost effective , that we have to prove, what we have paid to agency, I am not sure , it is about 2 lakh rupees, but if you are paying



two lakh rupees for updating data of only 500 members is not correct or cost effective . Dr Jawahar commented that “ it is also confirmation of other data” Dr Shiva said “ Why I am telling this ? I have cross checked that the day someone Manish called me from this agency , I have not received call and I went through my call records and confirmed it. Same may have happened with many other people also., that is why I have the proof in my mobile. I have some doubt in it , so I suggest to ask all these members to reregister themselves on our website . Dr Jawahar explained mechanism on website and how fields are added in detail.

Dr Thakkar suggested that “ He will write an email and whats app to all about 500 data of members updated by Dr Ram and will inform them that so and so agency has updated and so and so person from agency has contacted you on so and so date and they have updated your email Id and Mobile number. If you find any discrepancy , kindly go to website and correct it. Dr Sen said “ Yes Atul “Dr Atul appeared with video on and said “ I have small humble suggestion that we will not write agency name or we will not write that agency has updated data but there will be subtle change that we will just write that your data is updated and is on website , please check and confirm . We will send regular reminders to members , may be 5 reminders in 10 days ,then our job is done“ Dr Thakkar said , no problem our ultimate aim is to update member data , Dr Atul said further that “ it is up to the members to verify the data that it is correct or not , we do not mention the agency and how it has been updated . Your updated data is posted on website, please visit the website and ratify it . Dr Thakkar said correct , correct .”

So Atul objected in writing the name of agency , reason he may be knowing and he said that we are not writing that data is updated by agency , so we have not written that.

Dr Atul tried to interject saying “ Navinbhai “ , Dr Thakkar said “ please write down , let me complete then we will discuss”

Dr Thakkar projected next slide 31 and said “Dr Ram spoke

**I had in fact mentioned about my travel plans and non-availability to Mr. Nikhil Mittal Wrong fact – Was available to all – Multiple evidences**

in his speech that he had to travel overseas from 3rd June 2022 for a month to attend to

**Dr.Ram was at Canada and we called meetings and he attended it fully . He attended such 5-7 meetings and webinar , so he was easily communicable and must be supervising his team for OFF LINE DATA UPDATE .This sample video clip**  
**obviously he was capable enough to connect to his team from Canada, so he cannot make such excuses**



**So we cannot buy his argument during 31-10-2022 EC Meeting that he was at CANADA , so was not in contact with his Team**

his son who had met with an accident in August 2021 and he was unable to attend to him then.

Wrong facts , this must be a planned visit with tickets booked earlier, visa applied earlier . Dr Ram had also planned data update project and Dr Ram was desperate to take this project of offline data update , why ? This is not understood by many , but we all trusted him .

My request to you is that presently I am out of the country , I am going to share with you three numbers of VikRam Patwardhan, Rajesh Gandhi and Vishal kundani . Please set up the meeting where all of us are there including Me , I shall be make myself available..... We can do it in next 24 to 48 hours , bo problem.....”

Dr Thakkar said “ So , Dr Ram was ready to meet and we cannot buy his argument during 31-10-2022 emergency EC meeting that as he was at CANADA , so he was not in contact with Mr Nikhil Mittal and Team. Just to save himself he made an allegation on us that was not correct and true.

Dr Thakkar projected next slide

**On 31-10-2022 Meeting we have nowhere said that Dr Ram has done it , we only projected facts – see the full video of 4 hrs . We have never tried to implicate Dr Ram. We only did our duty and Justice Gupta suggested it as tampering and asked Inquiry committee. You have not said any time it as Mistake**

**But you tried to implicate Dr Thakkar and Dr Jethwa instantly to save yourself and we vehemently opposed with all facts , you kept MUM and resigned**

and said “ We, nowhere said that Dr Ram Chaddha has done it , we just projected only facts which can be seen in [full video](#) .All facts were also projected to Dr Sen and he himself analysed on his computer , when he was at newzeland .Dr Sen wrote answer in email to conduct meeting . Dr Sen cannot say that he was not in favour of calling Emergency EC .There is a document of mail , he may lie. You can see the full video of 4 hours , we have never tried to implicate Dr Ram , we have never said Dr Ram has done . We had shown all excel sheets and what are the facts . This was our duty to do this. We cannot fail to do this duty to show facts . If we have not done our duty to tell facts to EC ,Dr Kundnani may put charge that Office of secretary has not informed all facts to EC. We were doing our duty and Shri Justice Gupta suggested it as tampering of voter list data and asked for enquiry committee. Dr Ram has not said in that meeting about gobile.com as it was mistake of agency.

Dr Ram Chaddha had a chance to ask his agency and tell EC that this is the mistake by his agency, but Dr Ram made a sudden “U” turn to falsely implicate me and Dr Jawahar Jethwa. This was a sudden hurt to us strongly. Dr Ram tried to implicate Dr Thakkar and Dr Jawahar Jethwa instantly , why we do not know , we are not able to understand it.

We had not implicated Dr Ram or said anything bad about Dr Ram , we had only shown facts to EC as our duty. Dr Thakkar said to Dr Atul “ Sorry Mr President , you had given uninterrupted one and half hour to Dr Ram in physical meeting of 30-4-2023 at Delhi . I have taken sir only 30 minutes . You had given one and half hour. I am elected Hon secretary of IOA by majority , so you cannot deny , please sorry , I have to present all the facts to Ec members , this is my humble request to Mr President.

Dr Thakkar projected next slide on screen and said “ Dr Ram spoke in his speech and expected “ Mr President Dr Sen and Dr Thakkar should have rang or texted once to Dr Ram before emergency EC 31-10-2022” This was the requirement by Dr Atul and Dr Ram Chaddha. Dr Chaddha expected one phone call from us. Myself and Dr Jawahar Jethwafelt that on 31-10-2023 during meeting or after meeting .

Why you have not rang Mr Nikhil Mittal on that day or all these months to know the source of mistake ... Ek Bar .. Ek Bar ... Phone kar Liya Hota.... Hum Ko Implicate Karne Ka Try Nahi kiya Hota....

Dr Ram must have called or met Mr Nikhil Mittal multiple times , we do not know , that is again a matter of inquiry committee or Investigation. But Dr Ram had a chance and possibility to rang Mr Nikhil Mittal to know facts. Why he tried to do injustice to facts and Dr Thakkar and Dr Jawahar Jethwa. It was Dr Ram's responsibility . 

The enquiry committee is well aware of the members ire and the delay in submission of the report. Once we get all the documents we will submit the report.

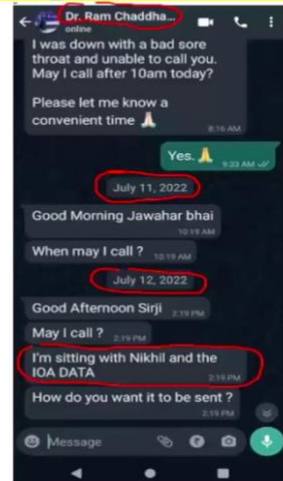

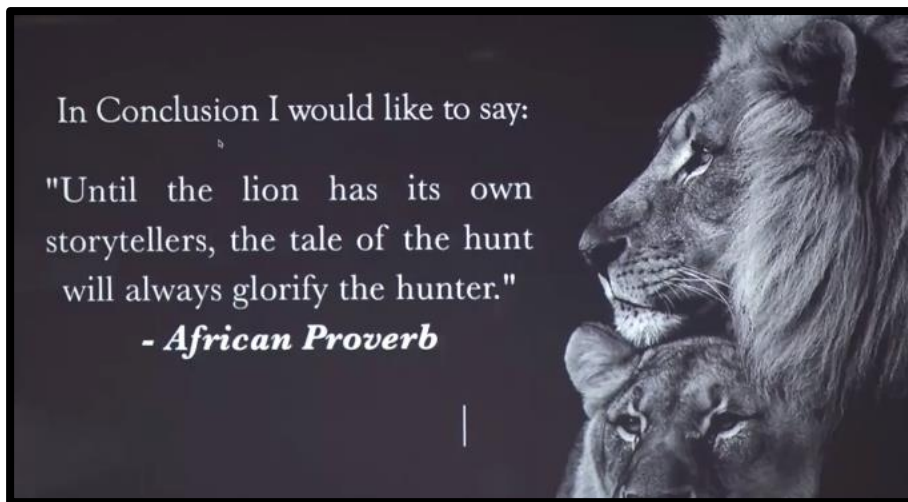

For now, subsequent IOA elections, GBM has decided that only Aadhaar verified members will be considered as eligible voter on voter list and linking and verification of Aadhar has started online on IOA website and more than 800 members have already verified their Aadhar online , so that no dead person name may appear in the voter list. There were repeated announcements made in the form of obituary google form from IOA office to state bodies and all members to fill form and to inform IOA office about members who are no more with us .....

This is the only TOOL by which we can do self-verification of all the members . There are many complaints and today complaint came from Satara, Maharashtra by senior orthopaedic surgeon that he has never made this email Id of .....243@rediffmail.com. Complaint is from very senior member Dr Vikash Mane practicing at Satara . There are so many members have different email ids and why it is so ,we do not know . There is only way to correct instantly online by Aadhar. Anyone who wants to speak for Aadhar can speak for Aadhar.”

Dr Atul –President IOA asked “ Are you finished with your presentation, sir ?” Dr Thakkar said , Yes sir , this was last slide , we can move forward “

Dr Atul Srivastava said “ Thanks , please do not interrupt now “ Dr Thakkar stopped sharing and made open for discussion.

Dr Atul said “ We have certain hands up Dr Sc Goel, followed by Dr Rajan Sharma, followed by Dr Jamal Ashraf, followed by Dr Karne and please be brief “ Dr Harpal complained that he has also raised hand , requested to include him also . Dr Thakkar

requested Dr Harpal to stop video to get bandwidth for uninterrupted audio from him .

Dr Atul said that Let him inform all as chair about one decision. And further said that “ I am very very firm on this . It was discussed in physical EC meeting on 30-4-2023 at length and today it has been rebutted at length. I had proposed to form the committee for sensitive issue , committee of five past presidents present at IOA House on 30-4-2023 and I stand by that statement. This committee should look into the matter between the vice president and secretary general . Committee includes like Dr S C Goel.. Dr Thakkar interjected and said strongly “ I have objection”. He said that there were some updated members were not included and he had pointed out which needed to be rebutted. Finally to our utter surprise, we were informed in the EC on last Sunday that Dr Ramesh did not get to vote. It was very much surprising to me that President of IOA does not have a vote . I called up Dr Ramesh Sen , called up , I mean I could not understand how it has happened and we never knew about it . I called up Dr Ram Chaddha ,

I called up Dr Ramesh Sen and called up everybody and what I found out that IOA sent list to agency had Dr Ramesh Sen name, agency sent list back to IOA had name of Dr Ramesh Sen , but in voter list name of Ramesh Sen was removed .We need to investigate that, why did Ramesh Sen get removed , need to find fault , Thank you “

Dr Thakkar said “ Thank you , can I answer Dr Atul or no need to answer as per your say .... Or You can go ahead for further discussion. Dr Atul said Dr Karne , then Dr Harpal. Dr Karne said” thank u sir. There are certain things happened wrong about gobile.com which everyone has accepted that was not correct as far as gobile .com , so there is no dispute that something wrong has happened . Only thing which happened in last Ec meeting and in this Ec meeting is pointing the finger , who is responsible for that . In last Ec meeting We heard Dr Ram Chaddha and he tried to convince everybody that it was a mistake of IOA office, Dr Thakkar and Dr Jawahar Jethwa, but now Thakkar has conveyed everybody that Dr Ram Chaddha has done all this . Dr Atul said “ With your permission , can I interrupt you ? With folded hands I would like to request all the EC members , Dekhiye , I have gone through Dr Chaddha’s presentation and on 30-4-2022 and I have gone through Dr Navin’s elaborate presentation today and let me tell you , that is why I propose committee because this cannot be solved just on the zoom. Each and everything is discussed with the persons , to come out for conclusion. Dr Karne said “ Can I elaborate sir ? Dr Atul said “ Yes” Dr Karne said “ Whatever has happened about gobile.com , there is already a Govardhan Committee looking after this particular matter , why this has happened and what are reasons for this to happen .So Only on this ground GBM has formed Govardhan committee and it is working . let the Govardhan committee come out with report . Dr Atul said “ can I again comment “ we are mixing the both the facts . Govardhan committee is formed to see for elections and here we want to form a committee for preelection process sir , both are different things , if you try to understand“

Dr Thakkar objected very strongly and said “ No, No, No, no ..... Govardhan committee is looking for gobile.com , why there was irregularity by Dr Ram that is why it is passed in GBM that if Dr Ram is found guilty by committee , Dr Ram has to be suspended that is written in the GBM minutes. Once the GBM has constituted a committee with same subject , EC has no business to constitute a committee on same subject “ Dr Atul said “ Ok , then we are not discussing this as Govardhan committee is looking after this.

Dr Thakkar said “ Yes GBM is superior than EC , so we are not forming any such committee . It is fact that in meeting at IOA house Dr Shivashankar also objected the same and so idea was dropped on that day only and decided for not to form committee . As S C Goel said, do you want to revert that decision on that day of EC ?, so do not make that point again. “ Dr Atul said “ Can I speak ? , Keep quiet when I am speaking “

Dr Thakkar said “ No No , when you allowed me to speak , then allow me to speak completely . you cannot curtail me” Dr Atul said “ have you completed ?” Dr Thakkar said , No , Let me complete it . Dr Thakkar reiterated again “GBM has formed Govardhan committee for it, IOA house meeting it was decided for not to make committee. Dr S C Goel has said not to revert decision and now you are trying to form a new committee , that is wrong “ Dr Atul said , can I speak , if you have completed “ Dr Thakkar said “second point , that it is not a personal problem of Dr Navin Thakkar and Dr Ram Chaddha , this is the



problem of IOA . So do not try to picturise wrongly which I had told you Dr Atul on that day also and you had accepted it . Dr Atul said “ You are again alleging “ Dr Thakkar , No No you tried it on that day and I pointed out that it is wrong and you had corrected your version and said that it is the problem of IOA data update and election officer and not the problem between Dr Ram and Dr Thakkar. “ Dr Atul said “ can you keep quiet “ Dr Thakkar said No No How van be I quite when you are saying wrong facts to EC, which I am correcting , that is all and I should be allowed to correct wrong things ” Dr Atul said “ It is not personal” Dr Thakkar said “ yes then you are right “ Dr Atul said further “ let me tell you , whatever you may say , this big fighting and whatever exchange of thoughts between you and Dr Ram Chaddha . Dr Thakkar interjected and said “ No” Dr Atul continued “ That has hurt IOA a lot “

Dr Thakkar said strongly “ No I object . let put on records that Dr Ram made a personal comments and allegations on Dr Thakkar and Dr Jawahar Jethwa that he was not supervised by him and it was supervised by us . He made wrong facts and said wrong to EC and that is our limited contention. “

Dr Atul asked Dr Jawahar to stop Dr Navin “

Dr Thakkar said “ Nobody can tell me I am enough adult sir. Dr Atul , you are trying to deviate the things and that will not be allowed .

Dr Atul said “ again you are alleging , what I am deviating ?

Dr Thakkar said “ It is very clear and say that it was a problem of IOA data and that committee is already formed by the GBM and there is no personal problem between Dr Ram Chaddha and Dr Navin and EC cannot form a another committee for same subject as GBM is supreme”

Dr Atul said “ keep quiet “ Let me speak , you have spoken “

Dr Thakkar said “ let me speak and complete what I am speaking . you are not allowing me to complete”

Dr Atul said “ You complete then I will speak “ Dr Thakkar said “ Thank you chair , there is no personal problem between Dr Ram Chaddha and Dr Navin Thakkar , make it crystal clear in minds of all EC members. It is a problem of IOA data and when the complaint came from Dr Anup , this problem got raised, otherwise , there was no problem and in that meeting of 31-10-2022 , if he had not said wrongly and tried to put wrong facts to EC with rebuttal from us. Now you and all know the facts , you read that letter of Mr Nikhil Mittal . So now you have to pass that we condemn what Dr Ram Chaddha said on 31-10-2022 and he has to retract back his words . As a chair , as a senior person, as elected member , as a custodian of IOA Dr Atul you must say now that facts are now clear that the Mr Nikhil has accepted his mistake and gave unconditional apology and Dr Ram also presented about mistake of agency . So please , this is a small request to you Dr Atul as a chair and all Ec members and request to Dr Atul Srivastav to remain impartial and tell that we condemn what Dr Ram said on 31-10-2022 Ec . this is a very simple requirement from Dr Jawahar Jethwa and Dr

Navin Thakkar and please do not deviate matter and this is the problem and there is no need of any further committee as committee by GBM is working on same subject “

Dr Atul said “ have you completed sir , can I speak now “

Dr Thakkar said “ Thank you sir completed can go ahead further now “

Dr Atul said “ I am concluding this issue that as you have said that this matter is under Dr Govardhan Committee . Let Govardhan committee come with its report . We will act accordingly . We are not forming any new committee and we move forward with our agenda ”

Dr Thakkar said “ Thank you . Dr Anup asked “ May I speak ?“

Dr Atul said “ Not on this issue , no one on this issue , let us wait till Govardhan Committee report , next is President advisory committee . “ No one responded , so next asked is UG PG Training . Dr Atul requested Dr Thakkar to take it forward agenda for a while . Dr Thakkar was busy in admitting members in zoom meeting .

Dr Thakkar asked , does Dr Sc Goel is here for Blue Book review committee? Repeated again but no response . IOA Building committee – Dr Vijay sharma , are you there ? . No response

## **Membership Drive Committee - Dr K P Raju and Team**

Dr Atul named different committee chairs and asked about their presence  
Dr Manneshi Bansal finally presented the report with President theme of String Bones , String nation . “ he informed house about the campaign and shown QR Code and how to join IOA online in a simplified way and suggested to have QR code printed in all CMES of states and drive advertisement in all Brochures .

Dr Atul asked other committee chair who are present . Dr Karne raised hand , so Dr Atul –Chair allowed him to speak till committee report ppt gets loaded . Dr Karne said “ Thank you chair , I wanted to tell two or three things which you did not allow me to speak last time also and in this Ec also. I want to say ONLY that Dr Ram has also accepted now that Mr Nikhil Mittal has done all the things , so there is no point in finger pointing towards either Dr Ram and Dr Navinbhai or Dr Jawahar Jethwahas done mistakes , so we move forward now as Mr Nikhil Mittal has accepted himself , so let everything continue toward Mr Nikhil Mittal. Second point I wanted to say that when the clips are presented there is difference between edited clip and altered clip . If someone wants to give evidence , so he cannot show whole video of 4 hours in EC , he can show the certain part of video or audio and that cannot be called edited or altered clip . Third point is Dr Navinbhai has shown the mail of the committee which Dr Ram Chaddha had sent to committee. If I am correct in last EC meeting , himself has shown his email to EC what committee asked him and that was presented in last EC , so it is not a big issue that Dr Thakkar has shown the mail which is connected to that committee.

Dr Karne requested that I will be presenting about Office orthopaedics .

## **Office Orthopaedics Committee - Dr N J Karne and Team**

Dr Karne projected slides of his committee report thing Dr Atul Srivastava about taking cognizance of this subject and informed about context and definition of office orthopaedics in Indian context to remove myth about it and invited any opinions/suggestions to change definition. He suggested nation wise faculty for selected topics to have pool of faculty for office orthopaedics in IOACON 2023 . Making a consensus in certain conditions like Tennis elbow , plantar fasciitis , frozen shoulder . He said that in future we will make National Association affiliated to IOA . Dr Atul thanked Dr Karne and said that he thinks enough time is given to him “

Dr Jamal objected and one correction for Dr Karne’s report and said “ Dr Ram Chaddha had read out a letter to the grievance committee and he had not displayed it and Dr Navin today displayed it . Dr Jamal said again “Dr Navin Thakkar has displayed today letter , Dr Ram Chaddha had read it and not displayed here” Dr Karne said “ Whatever “ . Dr Jamal said “ That means inquiry committee has given it to Dr Navin “ Dr Karne said , that is only twisting of words and Dr Navin Thakkar displayed what Dr Ram written to Committee.

Dr Thakkar said “ I will reply to this and say clear cut . On14th , if I remember very well , we received a mail from inquiry committee that you are going to be called in zoom meeting . It was combined same mail to me and Dr Jawahar Jethwa and mentioned that to answer your rebuttal to allegations made in letter with letter of Dr Ram attached where he is alleging you . inquiry committee had attached that letter , that is why I have that letter of Dr Ram to committee . letter which Dr Ram read out , same letter I have . I have displayed a portion of letter which he purposefully missed on that day and not read out full letter , particularly that portion of letter which I displayed here for information of EC “

Dr Atul said , that is cleared now , next agenda “

Dr Thakkar said “ I have put the explanation, Dr Jamal are you satisfied ? Dr Jamal are you satisfied or not ?

I want to ask the questioner Dr Jamal , he is satisfied or not ?

Dr Atul said that it is ok , Chair satisfied “

Dr Karne said “ I have last point to say as past Legal and grievance committee chair that , when IOA has filed in Delhi high court and it is better to follow that particular affidavit , otherwise it will amount to the contempt of court.. If we have filled an affidavit for Aadhar which I was not aware till this time that all subsequent elections will be Aadhar based and Aadhar linked “

Dr Atul said “ I have told the Secretary General that after this meeting , we will discuss with our lawyer and then move forward sir we will do nothing which harms the IOA . This issue was discussed in last EC and I have said that it will be a gradual process , how can we have only 800 members going for voting ?” Dr Karne said “ I agree with you , even if 4000-5000 members verify their Aadhar , there should not any injustice to other members , but there should be some mechanism to verify. “ Dr Atul said “ We will discuss with Lawyer and then move forward “

Dr Thakkar requested to allow him to speak “ I would like to say something . if you make it mandatory ,then and then everyone will do Aadhar updation, because we have already made mandatory that either email or mobile has to be there to be eligible voter., same wat Aadhar because there are problems .” Dr Thakkar asked all “ Do we agree that there is a problem in the list and there are complaints ?

I received complaint from the Maharashtra , number of members have said that we have not made this email Id , then who has made our email Id ? How to rectify this? ONLY way is Aadhar. So we needed the tool to verify and it is passed in GBM , where it is not written anywhere that it will be gradual process.

Dr Atul said “ I have a problem “  
You are saying same thing again and again”

Dr Jawahar Jethwasaid “ No No ,that is not the point , it is doable “ Dr Thakkar said “ It is doable easily then why a gradual process ?

Dr Anup interjected and said “ may I speak something on it “

Dr Thakkar said “ let me complete first , then you will be speaking , this is a small request to you Dr Anup, Can I continue , so that I can say what I was conveying to Ec members ?”

Dr Anup said “ Sir , I am just asking president sir , if he allows you , please continue sir and I will speak later , no problem “

Dr Thakkar said “ I was presenting already and Dr Anup you asked in between , that is why the rule is let one complete and then start other “

Dr Anup said “ I had raised my hand since 30 minutes”

Dr Thakkar said “ Now , it is up to the President , if he says I continue , I will , otherwise not “

Dr Atul said “ Navin , followed by Anup “

Dr Thakkar continued “ Ok Fine Thank you. Now it is cleared. We had concluded in GBM that there is a problem. There was a problem and it was discussed at length about it to make a voter list, update the data. There are issues of the spurious emails, spurious mobile numbers , so many complaints of previous data , which

cannot be verified by any individual or it cannot be verified. So after discussion in GBM, we decided that now IOA elections will be Aadhar based and Aadhar linked to avoid problem of dead members and to avoid possible spurious voters. It was discussed that spurious voters should not come in the list to prevent litigation and that takes away a good fund of IOA which can be used academically for young orthopaedic surgeons. So we have not said that it will be a gradual process. It was in the times of before 10 years, when internet connections were weak. Now internet connection is everywhere. Every person is well connected by mobile. So it has to be done immediately. If we say that we do not want to do from this year, that implies that we still want to continue with spurious emails and mobile numbers and again a problem in the court. Do You accept that? Do you want a litigation again, President Sir? You do not want it. Members do not want it and that was the opinion of members in GBM. It was decided and proposed and seconded. According to that we started on our website Aadhar self-verification online and more than 1000 have verified successfully. Now we have to decide in this EC that we make notifications to the members as we do notifications to update data by members themselves. If they do not update their mobile and email, they will not be eligible voters, same way they will not be eligible if they do not verify their Aadhar. This is the only which can be allowed by the court, if litigation happens. We have submitted in the court when court asked for this and according to advice of IOA lawyer, we have done affidavit. So it will be prudent to start from this year and we must pass resolution that we will make notifications Three-Four - Five times and after enough notification as done in update of data, if they are not updating, then they are not interested in IOA elections. Same way if they do not update their Aadhar, they are not interested in IOA elections. And then they cannot complain. As Dr Atul said that video you have seen and heard 3-4 notifications and then it is up to the members to update their data. After that they cannot say that we are not able to vote. Why we should not become TRANSPARENT from this year? Ant Reason? Any argument for this? Why in a staggered way? Why in a gradual way? Sorry, I think this is a palatable argument.

Dr Atul said "Ok, Dr Anup"

Dr Anup said "Thank you for allowing me to speak. Two things I want to present here which I have already presented in EC meeting on 30-4-2023. I definitely agree that Id verification of each and every member should be done and methodology should be adopted for the Transparency of the voter's list, but also I do agree that any affidavit which whatsoever, I do not know the exact language, whosoever has given in the court of law, then our Advocate of IOA will be right person. We should take a clear cut opinion of IOA advocate on this issue that how we can go forward to avoid any litigation" Dr Anup again repeated same and said "that is my submission sir". Dr Karne said "On one side correct that we have given affidavit in high court, if lawyer opines, then also some people may go against opinion of lawyer. Dr Anup said to Dr Karne "I will request you to ask the chair first to speak" Dr Karne said "I am giving my opinion on one side that is issue and on second side issue is for members who are not updating the Aadhar and if hardly any 2-3 thousand members will participate in election. So as we should make some arrangement as our members are very lazy, so we must give them as president said 4-5 notifications

and even after they do not do , that means they are not keen to vote for IOA Election . If we can give them mechanism to do it . Dr Anup interjected that “ Only person who can opine is IOA lawyer about legality . Dr Atul said “ Dr Karne’s point is well taken , Dr Anup are you finished , Dr S C Goel sir ?”

Dr SC Goel said “ We should take opinion of lawyer and what should be the minimum number to adopt it . I think at least 50 percentage members if does Aadhar verification we can do. If out of 15000, 7500 members do Aadhar verification , it is OK . Dr Atul said that “ we will discuss with the Lawyer and decide “

Dr Thakkar said “ can we pass a resolution that Aadhar is mandatory “

Dr Atul said I have objection , before passing the resolution , please consider my comment and minute it . Dr Thakkar said “ Yes Yes 100% , you can have comment “Dr Atul said “ I feel as a chair I ditto what Dr Karne said and I partially ditto what Dr Goel said . I feel it is a welcome and very important good step on the behalf of IOA of linking Aadhar verification to the voter list , but I very strongly feel that it should be a gradual process , so that maximum members can participate and I agree with Dr Karne that even if 100 members are denied their right , that is not correct , so let it be a gradual process . I am totally for it but starting t from this year , where 2000 or 3000 of Aadhaar verified list will be injustice and secretary general , we will be inviting litigation , then . Dr Thakkar said to Dr Atul that “ this is your assumption that only 200-3000 members will do Aadhar verification. At least we have to pass a resolution for notification that please update your Aadhar “. Dr Atul interjected that you have to pass resolution that mandatory Aadhar verification is required for update , but not for voting for this year” Dr Thakkar said “ Ok Ok , we can pass a resolution that Aadhar is mandatory for update and we will give notification for that as per the written advice of written document from our lawyer that we have submitted this affidavit in Delhi high court , if we are binding to that , it will become compulsory that only Aadhar verified members will be able to vote “ Dr Atul said “ Yes we will discuss with the lawyer . “ Dr Thakkar , not only we will discuss , we have to get written document from IOA lawyer . Dr Atul said “ Ok” . Dr Anup said “ perfect “ . Dr Thakkar cleared further that again we can meet and discuss but till that time we will send notifications to the members and resolution will be “ It is mandatory to do Aadhar verification in update , but it will be applied to become vote only once high court clears it and written document received from IOA lawyer of no objection “ Is it right sir ? “ Dr Atul said “ No , That is not right . I think we pass the resolution that we will make notifications to all members that it is mandatory to link your Aadhar and update your profile that is enough “ Dr Jawahar Jethwasaid “ Let us give multiple notification “ Dr Atul said “ Yes “ . Dr Thakkar said “ Ok , so we are now passing the resolution that we will give multiple notifications to members that “ it is mandatory to link your Aadhar and update your profile “ meanwhile ,we will get a letter from IOA lawyer and comment from the High Court , if comes . Dr Atul said “ That is not required to write . Dr Thakkar said we are not writing in resolution that part , but it is a part of discussion and decision making .

Dr Anup asked , is it Mandatory for Aadhar , or any other Id will also work ?

Dr Thakkar said “ It should be Aadhar because it is universally accepted and instant to verify. “ Dr Anup said “ I have no objection to Aadhar , but suggesting to avoid litigation .

Dr Jawahar Said “ Let us start the notifications “ Dr Thakkar agreed and said yes we are starting notifications Dr Thakkar said that “ we are starting from today notifications that it is Mandatory , right ? Dr Atul said “ right , next agenda “

## **WOICE Committee - Dr Aarti Dewan and Team**

Dr Aarti presented WOICE – Female wing report and thanked for dedicated one hour , Mulla Firoz session and said they are more than 300 members in WOICE. She projected all progRams done and WOICE members remain present in all academic progRams and thanked President and Hon sec. She mentioned activity done in APOA by Dr rujuta Mehta . She mentioned all webinars done by WOICE. And inspiring symphonies in SICOT. She requested Mulla Firoz best paper into Gold medal. Dr Atul said that we have received this proposal for gold medal . He asked all members and it was passed for gold medal

## **Presidential Theme Committee - Dr Amarnath with team**

Dr Amarnath presented report of osteoporosis guidelines by Delphi method with questions asked to orthopaedic faculty and other branch faculty like Nephrology, Endocrinologist , Gynaecologist, Rheumatologist etc as Team and having meeting . More than 60 questions made for Delphi method and it will be circulated and we will get responses and we will make GUIDE LINE . We will be ready to make YEAR BOOK . Dr Atul thanked and wish made that YEAR BOOK will get released in Lucknow.

## **Disaster Management Committee - Dr Manoj**

### **Choudhary and Team**

Dr Manoj Choudhary presented his report with definition of disaster. He informed house that how team will be made with NDRF team and will get input and training from NDRF .

## **Medicolegal Committee – Dr Rahul Katta and Team**

Dr Govind Purohit presented his report and suggested that committee is ready to help each and every member to prevent litigation , for that education, seminars and CME on that subject and webinars . After incident happens how to tackle etc . How to take consent and what are important points and record keeping . all points he narrated in slides after some difficulty in projecting slide. Dr Karne suggested to add the point of giving suggestion to all members to go for indemnity insurance as IOA has done lot of efforts to get subsidised premium and all facilities for IOA members from Cover You and ask them who are owning the nursing home to take insurance for Nursing home also and third point you take issue of violence to doctors and that is also important. “

Dr Atul and Dr Govind Purohit thanked Dr Karne for valid suggestions . Dr Atul asked any committee chair now remaining ?

Dr Harpal requested that he is waiting for his turn since morning . Dr Atul said , Dr Harpal “

Dr Harpal said “ Sir I request the chair and other honourable Ec members to give me a patient listening and not disturbing in between. I will be addressing to Chair as a norm but my message should go loud and clear to whole EC. Sir , with due apologies , I would like to submit first who conducts the Ec meeting and who is the chair in EC meeting ? It does not seem to be your Ec and you are conducting the meeting , I am very sorry to say that and I want this on record as a EC member , I am elected EC member from North Zone and state representative from Punjab. Second , Sir , I have written a letter to you regarding GOA extraordinary GBM minutes and the videos and not received any answer on this. Neither this point is raised in this Ecmeeting . minutes have been fudged , this strongly I am in knowledge because I was present during the EGM and minutes have been fudged , we should make this front of Ec , so that truth to come out. Sir my third point is Govardhan Committee is looking into Election fiasco that is ok, but how come Dr Ramesh Sen’s name was missing from final electoral list ? If so called culprit Nikhil Mittal has put his name , how did other people’s name whose obituary are in the list , there should be a committee to go into a detail and who so ever is responsible for it ,same sentence should be given to that person as promised in Govardhan Committee. Ec has to accept this and we will take it up in GBM also.

Dr Atul “ Dr Navin “ Dr Thakkar said “ Sir “ Dr Harpal said “ One more point from me . Secretary general or Hon Sec , I am not finding which is the term I have to use , he is the person running the association as per morning presentation by Dr Navin that he is the responsible person to run the association , I fully agree with that. I am going to use same terminology here , if he is the one who is running the association, how was the list of IOA members was given to Nikhil Mittal without memorandum ? Who shared the list with Mr Nikhil Mittal without memorandum ? This should also in purview of inquiry committee. If there was no MOU signed and IOA office was not aware , why was the payment released ? This should also be a part of inquiry committee. This is not a Jaise Punjabi me kahte hai , not a personal jagir of someone . How can you sign a cheque without signing a MOU ? How can you forward the list ? Wethere it is Mr Pandey , Mr secretary , A B C or X Y Z , nobody has the authority to give a list to third party and it is members’ money , how it was paid , who signed the cheque without a MOU ? Whose responsibility is , we have to fix the responsibility. Why was the cheque signed ? kal kya me authorise kar dunga to kya aap char lakh rupiya sign kar ke de donge ? we want answers to all this . “ Dr Atul said “ Dr Navin , unmute yourself “ Dr Thakkar said “ Dr Harpal , you have seen on screen that payment is done by Chairman of finance committee Dr Atul as documented in Treasure’s mail “ Dr Harpal said “ If you do not have the MOU , finance committee cannot do payment “ Dr Thakkar said facts that “ MOU was going to be produced by Dr Ram as responsibility was given to Dr Ram . Dr Harpal said “ If you are the



custodian and if there is no MOU , no payment should be done “. Dr Thakkar said to Dr Harpal “ Yes you are right , so you say that putting a trust in Dr Ram was the fault. Dr Harpal said “ No sir I am not saying that “ Dr Thakkar said , yes it was Dr Ram’s responsibility and not done , so it was fault of Dr Ram , yes it was a fault , agree. Dr Jawahar Jethwasaid “ We trusted Dr Ram , that is why process was on . We should not have trusted Ram , yes agree “ . Dr Thakkar said further “ Dr Harpal said that list was transferred to Mr Nikhil Mittal by Hon secretary . , Sorry , IOA office had given list to Dr Ram Chaddha and Dr Ram Chaddha has transferred list to third party his man Nikhil Mittal even before Nikhil Mittal was decided as vendor . Dr Ram was supposed to give IOA , vendor’s name , details of team members to be circulated to members to assure members that there is no spurious call asking email ID and mobile numbers , but Dr Ram has not even submitted that to IOA . Dr Ram was supposed to give proposal with vendors quotation before finalising vendor , but he has given all quotations after one month of completion of work , just before signing the cheque , kindly see treasure’s mail as evidence projected in morning here. Dr Ram submitted all quotations and bill to IOA and within half an hour Finance committee chair Dr Atul Srivastava has passed the bill and treasurer has given the payment . So you indirectly say that Dr Atul and Dr Navin Thakkar should not have trusted Dr Ram Chaddha . Dr Harpal said “ I am not saying trust this one or that one , but payment should not have been done without MOU .”

Dr Thakkar requested Dr Harpal and said “ Let me complete , problem came only when there was gobile.com. So many projects are going on together . Dr Harpal , you have not passed in IOA for copy right . Who signed for copyright ? where is the memorandum of copyright of IOA for book which you got printed . Can you answer this ? Dr Harpal said “ What copyright ? Dr Thakkar said “ why you have printed that book with your photo ? Who has given authority to you to give copyright of IOA to third party ? What is the document ? Give us the document . Dr Harpal said “ Give me the chance to reply Kerala.... Dr Thakkar said “ I have not completed , let me complete . Dr Harpal said “ Yeh bat ko deflect kar rahe he”, fash gaye to defect kar rahe he “ Dr Thakkar said “fash nahi gaye he “ Dr Jawahar said “ Bilkul fash nahi gaye he “ Dr Thakkar said “ jara bhi deflect nahi kar rahe he, harpalji aap ek bat batao ke copyright club company ko dene ka document kanha he ? IOA office me he?” Dr Harpal said “ me batata hu ap ko Aap office me baithe he , ap batinye Kerala orthopaedic association ne copyright ka document diya tha ? Document kanha he ? Dr Thakkar said “Tab me IOA secretary nahi tha “ Dr Dhaval said “ IOA Ki bar karo , where is the copyright document ? Dr Thakkar said “ Ap ne book Chhap di . Ek bat EC ko batao ke apna akela photo chhapave ke ap kay apni publicity karna chahte the ? Dr Harpal said “ Sir I am not contesting any election .and everybody knows me so no need of publicity sir “ Dr Thakkar said “ Dr Harpal pahle mera saval sun li jiye , ungly Karne se pahle das bar socho . Do not get feeded by someone . Apne author se sign liya before printing the book , No . Have taken permission of Dr Jawahar Jethwabe before printing his article ? Dr Harpal said “permission is taken , ask him to check his email sir , Dr Harpal do not try to point finger to someone , their fingers will be pointing towards you. Do not try to do this “ Dr Harpal said “ I know you are very good advocate you have started it “

Dr Thakkar said “ we have not started , we have answered your questions . harpalji agar ye gobile.com ka gotala nahi hutha to koi problem hi nahi tha ”

Dr Harpal said “ you deleted purposefully name of Dr Ramesh Sen from voter list “ Dr Jawahar answered” No body will do that purposefully . It cannot be “. Dr Harpal repeated same sentence again. Dr Thakkar said to Dr Harpal “ Ap ka bahut kuch khul sakta he “ Dr Anup requested to Dr Harpal to stop and let us go ahead sir . Dr Karne said , stop it , now personal allegations are done . Discussion should be point by point and no need for personal allegations “

Dr Atul said “ what about the question he asked about Extra ordinary GBM minutes ?”

Dr Thakkar said to Dr Harpal “ as you are talking about MOU and vendor . I had asked for the EC, but Dr Ram insisted on CEC . prof Sen said CEC se kam chal jayega , Dr Ram Chaddha ne bola CEC me kam chal jayega right ? “

Dr Harpal said “ pahle ye ap batinye Dr Sen ka nam kaise delete hu voter list se ? Voter list me obituary vale kese aa gaye ? Dr Thakkar said “ we have asked Mr Pandey , you will get answer . Dr Jawahar said “ Yes we will get answer “ Dr Harpal said “ Is ki inquiry honi chahiye “ Dr Thakkar said “ is ki inquiry honi chahiye ki Club ko kisne IOA ka copyright diya , we must pass the resolution that How a person can do personally for IOA’s property copy right . How can copyright of IOA can be used without the permission of IOA ? Dr Harpal said “ Kerala ki inquiry hogi , Jaipur ki bji inquiry hogi , sab ki karo . Kisine nahi Kiya . Dr Thakkar said “ Dr Ramesh Sen sir has said that Dr Harpal has not taken any permission from him “ Dr Harpal said “ Kochi ne bhi nahi li he “ Dr Thakkarsaid “ Koi Char rasta pe nahi rukta he lal light he , to kya ap bhi nahi rukenge ?” Dr Harpal said “ Na Na , sir Ab Kochi apake Favour me he to Aap uski inquiry nahi karoge , kyonki aap ko election ladna hai why are you protecting Kochi ?” Dr Thakkar said “ There will be committee for copyright . We have nothing against anybody . We have nothing personal against you or Dr Ram Chaddha , magar aap ko feed kiya ja raha he usme dekh kar aap padhte ho , Aapp Ec me bhi aap ko jo feed kiya gaya ho voh hi bolte the. Sab ko sab pata he “ Dr Harpal said “ Dr Thakkar mere ko koi ko feed Karne jarurat nahi he , aap ko adat hogi feed Karne ki “

Dr Atul asked “ Dr Ram Chaddha are you there , Dr Anup are you there ? . I am feeling a bit unwell requesting you to take agenda forward from this “ Dr Anup said “ I am here , Ram sir , Ram sir “

Dr Atul asked Dr Thakkar “ what is about Extra Ordinary GBM minutes and minutes of 29 Nov Ec at Amritsar ? “

Dr Thakkar said “ That has been already given to Dr Sen and IOA office and it was circulated to all EC members at that time and also printed and pasted outside hall of GBM as per norms “ Dr Atul said “ why it is not on website Dr Jawahar Jethwa?” Dr Thakkar said , this will come in next newsletter and published on website . We will put on website , no problem . Dr Jawahar said “ why not ,why not , we will “

Dr Thakkar replied to Dr Atul clearly that “ Dr Atul , you know very well that we all five had discussion at that time with the constitution committee . We all together who signed copy of GBM minutes discussed together , where you said and every one said that on the screen amendments were done and passed and further immediately after EGBM, there was GBM , so there was no question of writing the minutes . Amendments were passed and further ratified . if extraordinary meeting is on different date or at different timings , then it is possible , but when it is immediate followed by GBM , so GBM minutes have included ratification agenda and we all have signed and that is also further ratified in Amritsar GBM without any objections.

Dr Jamal said “ You as a president of IOA and previously president Dr Sen are elected members of association and are called officers of association or the Ec , no one has the power to pass a resolution that contravenes the constitution. The constitution says that every meeting has to be minuted , it is in the constitution . So whatever five gentlemen decided is inconsequential. Dr Thakkar said “ It was a collective decision and was not my decision. “ Dr Jamal requested to let him complete without disturbance and continued “ So the minutes of Extra ordinary GB meeting has to be circulated . Dr Atul said that “ Yes it is to be circulated , chair is demanding . Dr Thakkar said “ there was no minutes at that time because it was combined decision as per reason mentioned previously of all five together including you Dr Atul “ Dr Atul said “ At that time Dr Ramesh Sen was President , Today , I am here as President and I as President demanding it” Dr Thakkar said “ No No, at that time Dr B Shivashankar was President and he is absent today “ Dr Atul said “ Whoever was President , I am the President and I demand for the minutes “ Dr Thakkar said “ Ok “ Dr Jamal repeated that “ Five people cannot decide that “ Dr Thakkar smiled and said “ kafi decision ap ne aise hi liye hai, Dr Jamal , apne foreign affairs ki meeting bulanye bina mere ko out rakha tha that was not constitutional “. Dr Atul said “ kanha se kanha pahonch jate ho “. Dr Thakkar said “ Me sub kuch bata dunga sab ko , you have fudged many things , so chuhe marke Bili haj Karne nikli he , kya bat karte ho . Dr Jamal you have not submitted foreignaffairs details till today in spite of discussion in two times in Ec meeting and also in GBM it was discussed , you have not followed that and asking somebody else ?” Dr Atul asked Dr Anup to take further as he is not feeling well and allow him to leave the meeting . I am asking permission of Ec to leave , Dr Anup carry on “ Dr Anup asked , from where onwards I have to carry forward ?” Which agenda ? Dr Thakkar said “Agenda is now if committee reports are over , then letters from members “ Any committee is remaining ? Dr Atul said “ please carry forward , I am not well . Dr Thakkar said “ Ok , Dr Atul please take care “ 3d printing remaining and Dr Vikash Jain has sent PPT to me but if he is there then he will present .

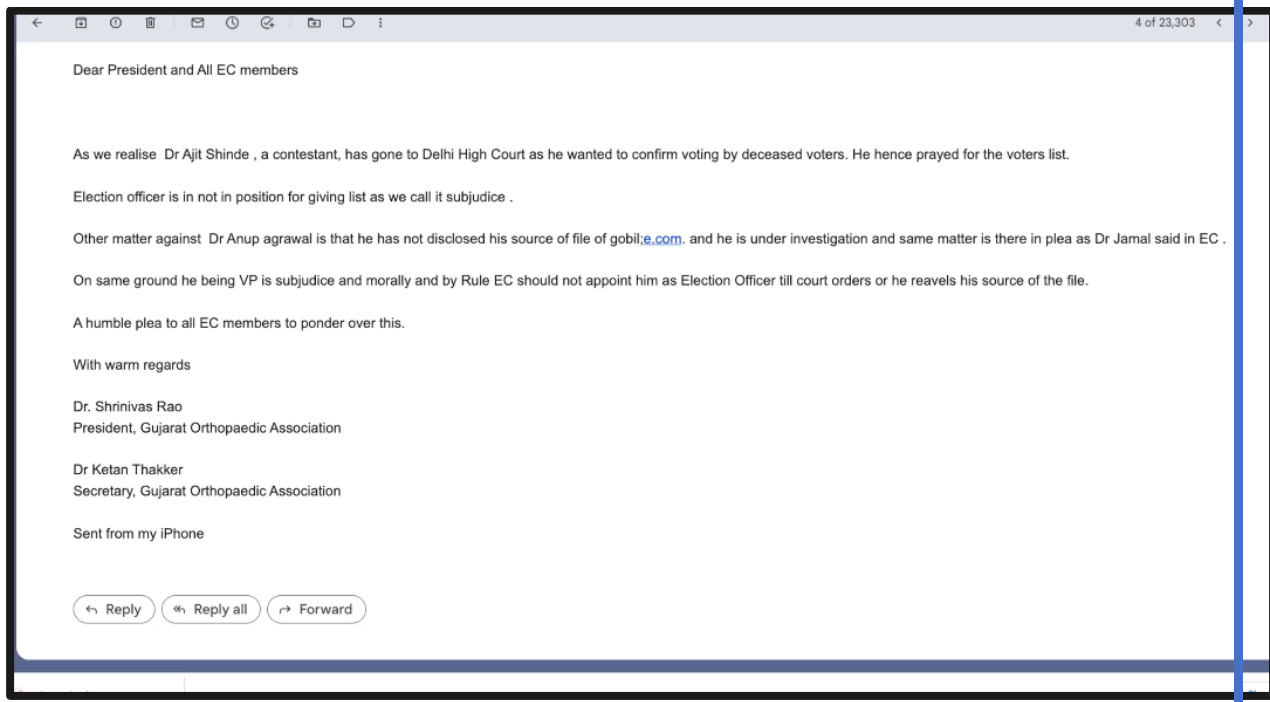
On same ground he being VP is subjudice and morally and by Rule EC should not appoint him as Election Officer till court orders or he reveals his source of the file.

Dr Thakkar asked Dr Karne as he has raised hand . Dr Karne said “ Election officer post is very sensitive post and we have seen last time also that this post creates lots of problem ,so if at all we want to avoid litigations , it is better to wait till court result comes . there is no need to hurry . last year we had to change the Election office on 12<sup>th</sup> hour and as matter is subjudice and it is under suspicion , it is better to wait to declare Election officer to avoid just now any litigations

Dr Harpal said “ Election was conducted under the supervision of High Court justice and conducted by CDSL and was validated by GBM , results are declared and validated by GBM , till there is a decision any otherwise , there is nothing to suggest we should stop the election officer from working “ If Dr Shiva could do it last year in 3 days or such a short while , decision to change election officer we can do as per court directions, till that time vice president stands for his post and as a part of his duty he can do duty of election officer and we are not holding any election in 2 weeks anyway , so why there be any change ? “ Dr Dhaval Desai asked “ Why there should be not , Dr Harpal ?” Dr Harpal replied “ Sir , he is duly elected officer of IOA. Dr Desai said “ But there is already an issue which is subjudice matter in court , so it is not wise for him “ Dr Karne said “ It will be a great disgrace to him and IOA, if at all we have to change election officer , it is better to wait . Dr Anup as acting chair requested all to speak one by one and asked Dr Dhaval to speak if any “ Dr Dhaval said “morally it is not right and I also asked question last time and you asked all questions to all for impunity of yours , but we also as voter we do not want police standing at our door or answer letter from police . We are again repeating same story of wasting time and money of IOA unnecessarily . Where are we going . we are going nowhere. Our all energy is getting wasted . It is the disgrace to all of us. “

Dr Jamal said “ Just for the benefit of EC , what I am pointing out that the elections were conducted out by Dr Atul Srivastava at that time and till date election of secretary general - Dr Navin Thakkar as well as the president Dr Atul Srivastava and even Lucknow are under question under court of law and we all are subjudice . Election of Vice president – Dr Atul Srivastava, Secretary general – Dr Navin Thakkar and election of Organising secretary of IOACON2023 , as of today all are challenged in court of law . So sir, when 3 of us gentlemen , or I say only men are not subjected to certain clause of morality , then why it should be subjected to someone else.. Dr Govind purohit raised hand said” We should take legal opinion from the lawyer before deciding this issue . “ Dr Dhaval said “ That is right “ Dr Anup said , Navin sir Ap Kuch kahana Chahto ho “ Dr Thakkar said “ mera Kaina ek hi hai ki log ye saval puch rahe he , people are asking question that if voted member list is to be given is subjudice , then in same court , same plea of this subject ,then why this is also not subjudice . I am not able to answer members this question” Dr Jamal said “ Can I answer it for you ?” Dr Thakkar said “ Yes , Please “ Dr Jamal continued “ The court has sealed , you and I have read the court thing , court has sealed list received from CDSL and made notings on it . Court has not, although the plea of plaintiff is not let Dr Anup Agarwal take position or charge as vice president . This plea of plaintiff court has not accepted and allowed Dr Anup Agarwal to continue as vice president. So court has allowed him to continue as vice president and court has sealed data received from CDSL , it is very simple . Dr Karne said “ can I interrupt ? Dr Jamal is giving wrong information here to EC.” Dr Saket jati said “ Karne sir I have raised my hand and it is my turn , Dr Anup said “ Dr Saket jati , please “ Dr Saket jati said “ Thank u Vice President – Chair sir . Dr Anup Agarwal is vice president . I think election is done by the vice president of IOA., that is it “ Dr Karne requested to speak and said “ Information given to EC by Mr Kamal Ashraf that the court has sealed the data , it is not so , court has asked to give that Data in sealed envelope and not inhibited CDSL from anywhere or they have not sealed the data at source at CDSL, so wrong information should not be given to EC. We can ask to CDSL to give the Data. I agree with Dr Dhaval Desai , we do not have anything against Dr Anup Agrawal as far as legal issue , but for moral issue what we are saying is about morality . Legal fights can be on both sides “ Dr Anup interjected Dr Karne and said “ I will answer on this issue of morality “ Dr Karne requested him to let him complete first. Dr Karne continued “ Another point Dr Jamal has said about Dr Atul Srivastava around 3 years ago , but that time environment was different and situation was different , but now the situation is murkier and with lot of suspicion . On that ground I am saying . legal battle we can do , but for betterment of IOA as Dr Dhaval Desai has said , when there is certain suspicion , we should wait till court verdict , then we can declare you as election officer , that is the issue I am saying and let us wait for the verdict for the benefit of IOA and not for legal point “ Dr Anup said “ Sir let me make clear it on issue of morality you talked about . I think I have quiet moral obligations and I am committed to IOA . As far as allegations are concerned , there are many people can make any allegations , that does not mean that it is proven fact. Let court decide I am vice president or not . Till I am vice president I am going to do my constitutional duties towards IOA. Let court decide . if anything has to be taken , we can always take an opinion of IOA advocate on this issue whether Anup Agrawal can continue as vice president and follow his constitutional duties of

election officer or not , so we can get the opinion of IOA advocate on this issue “ Dr Thakkar said that , so now we pass a resolution that “ We will take the legal opinion of IOA Lawyer and we will do needful , is it so Dr Anup as you spoke ?”

Dr Anup said “ Both , I have said that I will follow the constitution and as far as constitution is concerned it is my moral and constitutional duty to work as election officer till court gives any decision against this “ Dr Thakkar said “ Ok, but you said that we will take written legal opinion of the IOA advocate for this matter “ Dr Anup said “ We will take written legal opinion of IOA advocate that whether constitutionally or legally Dr Anup Agrawal is authorised to do his work as election officer or not “ Dr Thakkar said “ Ok, Fine “ Dr Harpal said I have to say something before you write the minutes. Dr Harpal said “ Sir, previous election which is challenged in the court and as per messages Election officer is made accused under various sections of IPC in charge sheet . In this election Dr Anup won the election as vice president , as of now there is no police complaint or a charge sheet filed in in court case . Two facts are clear. If election which is tainted by Charge sheet , that person can continue in office , what is stopping a person to continue in office , where there is no charge sheet , no stay from court . How can you stop him working ? Please answer my question . Pichle election officer pe charge sheet ho gayi, court me kes chale gaya, ush ko to ap kuch nahi kar rahe ho , ush ki koi moral responsibility nahi he, ush ko ap continue kar rahe ho office me, lekin jisme koi charge sheet nahi he, ush ka koi stay nahi he , koi police inquiry nahi he, ap kam nahi kar sakte, legal opinion lo pahle , how is this justified. Dr Thakkar said “ Dr Anup himself has said for legal opinion , he is not god , he is vice president seating on chair today, tomorrow will be another vice president . No need of legal opinion .

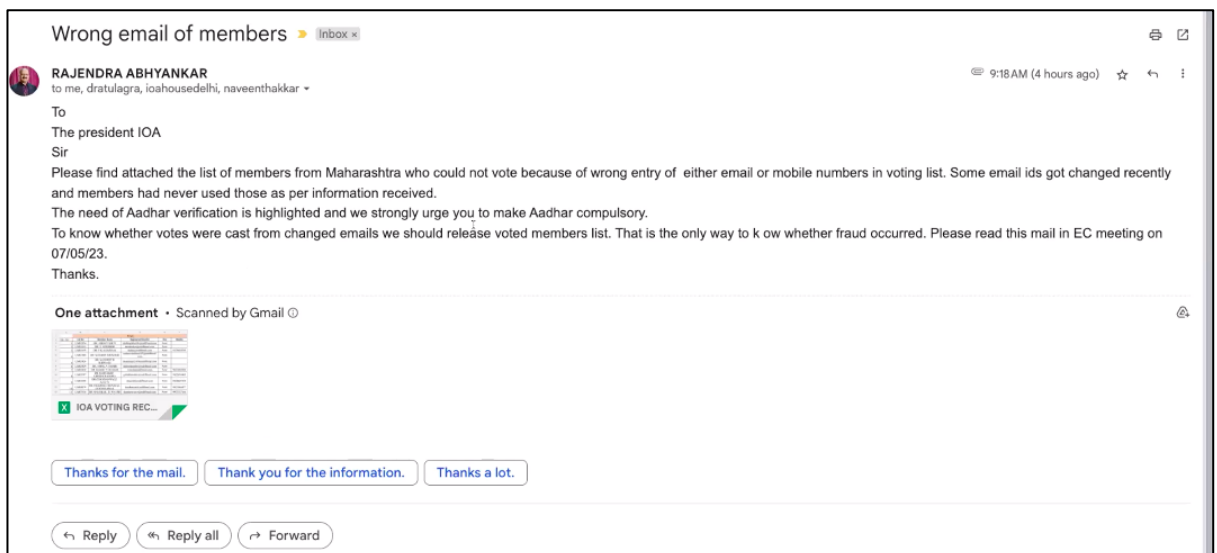
Dr Dhaval Desai said “ I think you are deviating from the point dr Harpal , what is more important is safely conduct this election and do not repeat the same mistake. Dr Harpal said “ Dhaval sir , with due respect we are not conduction election within the month of May , we will be conduction election in month of November , by that time things will be clear. Dr Dhaval said “ Opinion lene me kya harj he yar, putting on records that opinion of lawyer , what is the problem , I cannot understand , what is the problem ?, It is safe for Anup, it is better for Anup , in fact he was also saying in last Ec that I will take legal opinion on this issue etc” Dr Harpal said “ I have put my point , let wise people decide “

Dr Karne had raised hand . Dr Karne said “ I would say same thing again , legal things are different and takes lot of time and we are in the EC , so to avoid any future embracement , which may happen on 12fth hour in the month of October -Nov. There is already inquiry is going on with inquiry committee , so at least wait for inquiry committee report to come , so there should not be disgrace to IOA , undesired result come out of it , so let us wait . I am not saying that Dr Anup should not work and do duty of vice president but as far as election matters are concerned , they are highly sensitive and that take years together and unpleasant things have happened in the past , so I have humble request that we should wait till committee report of some inference come in Dr Shinde’s Case and then we can go ahead with this . We should prevent embracement for IOA

Dr Anup said “ Dr Karne perfect , so I take your point from here and you said that you have no objection in me and I am following the constitution as vice president . In last EC meeting , I had presented my duty , constitutional duty which is allotted as election officer that this has to be done . Main role of election officer will come , let us say in June and July onwards , when election would be conducted . So there is plenty of time . As far as EC has no Power to disallow any election officer , Ec does not require to give permission vice president by constitution has the power to do his duty as election officer . Matter is already in the court , so let court decide. If any adverse thing comes from court , naturally any IOA officer will not be able to do his constitutional duty of it , if any adverse comment comes from the court , is that OK , We go ahead ?

Dr Thakkar said there is second letter from Again Dr Rao related to Aadhar . Dr Anup said , we have discussed this issue , so no need to discuss again “

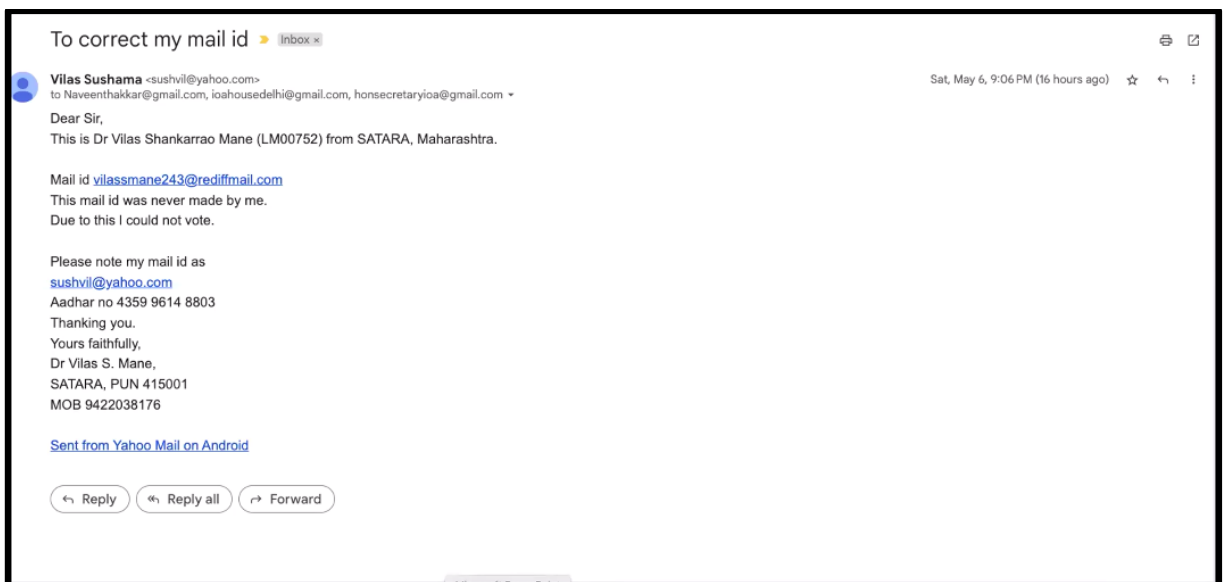

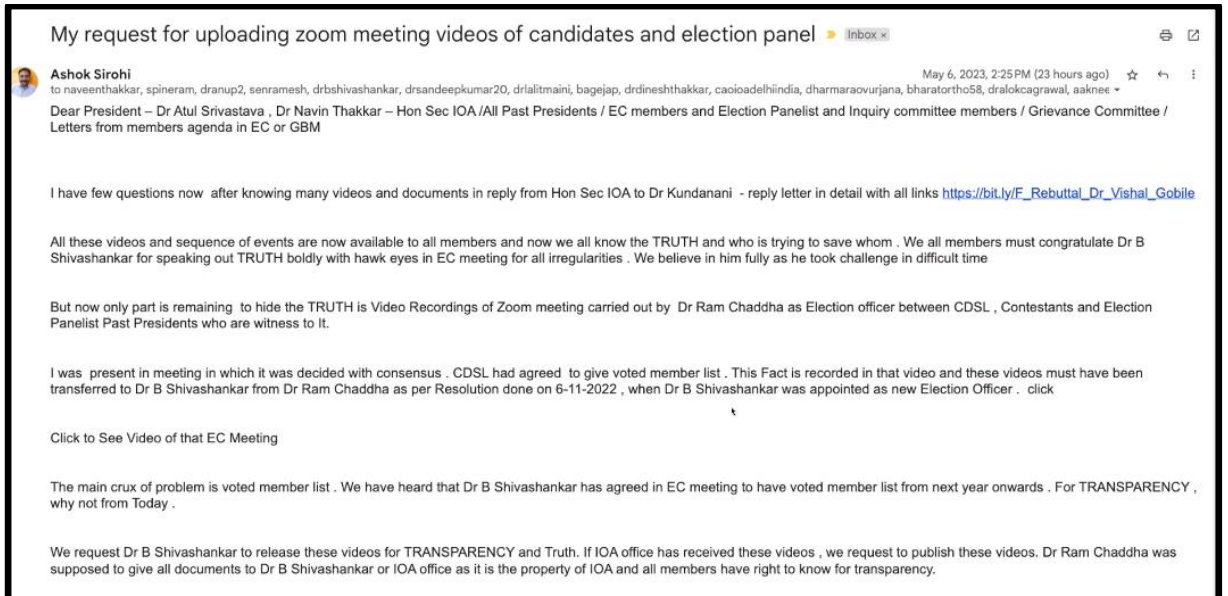

12. When this was brought to notice of the EC many times in the past and is documented in some of the minutes. A certified copy of the constitution was asked for in the Objections to the amendments passed at IOACON Goa why was no action taken and a copy provided?

13. Laid down procedure for holding meetings. 3 serially numbered registers have to be maintained

a. Agenda Register which should have the agenda written/ pasted on it on the left page and on the right signatures of the members or information how it was communicated

b. Attendance Register for the meetings.

c. Minutes Register where all the minutes should be recorded which are to read in the subsequent meeting and when approved signed by the Secretary and the President/Presiding Officer

If pasted then every page should be signed across the register and paper. *Does IOA maintain these registers?* **No only an Attendance Register is maintained.**

14. The *Constitutional Amendment Committee* of Dr SC Goel and Dr Jamal Ashraf plus Dr Atul Srivastava (having been past Presidents and/or Secretaries of UP) were aware that even in their state **renewal of Societies has to be done every 5 years, submission of audited balance sheets and every amended constitution has to be certified to be a valid document.** This issue was raised in my objections to the amendments. Why was no action taken in January 2022?

15. Why was the legal advisor who was paid Rs. 3 lacs to help out with drafting the amendments doing in this matter? Did he not know the Societies Act 1860??

16. **Why is a copy of the original Memorandum of the Association not available on the IOA website?**

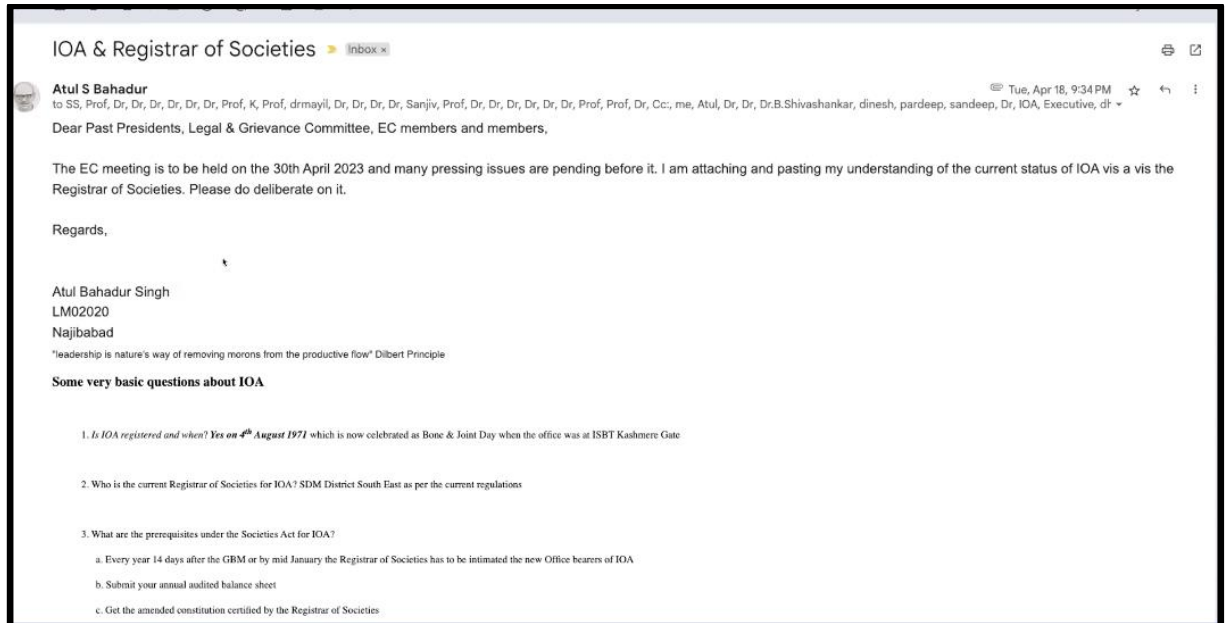
17. **Last but not the least what is the legal status of IOA as a society today under these circumstances?**

So now it is open for members of IOA to decide on the incompetence/ legal faux-pa of the Presidents and the elected executive, especially the past and the present Hon. Secretaries who are the custodian of IOA in the last 20 years or so, for the what they have done.

Ignorance of law can never be an excuse in any court of law, especially when every state chapter gets their society renewed every 5 years. This has been going on for over the last 15 to 20 years at least. Delhi is peculiar in a sense that societies don't have to be renewed every 5 years. **But then why were the other mandatory guidelines under the Societies Act 1860 not complied with?**

Given these facts IOA needs a newly drafted constitution from scratch to reboot to IOA 2.0 before the Diamond Jubilee (75<sup>th</sup> in 2026) with the coterie/ election mafia being given a boot for good


