Eligibility criteria for IOA official post will be as per amended constitution of IOA

- i. Minimum of 5 years of Life membership of IOA at the previous Annual General Body meeting of the IOA is required to contest for any post.
- ii. Life members whose membership has been verified, are only entitled to contest and cast the vote
- iii. He / She should be an Indian Citizen and shall be staying in India on permanent basis.
- iv. He/ She should not be convicted in any criminal proceedings by any Indian Court of Law.
- v. All contestants are advised to strictly adhere to the Code of Conduct to avoid forfeiting of their candidature.

vi. For the post of Vice President

- a. Applicants who have served IOA in capacity of Secretary General, Joint Secretary, Treasurer or Editor as officer of IOA are only eligible to contest in subsequent year of election and not the election of the year where applicant has completed the term of office. For example, those who have completed term in 2024, can contest for IOA Election 2025 and subsequent.
- b. Applicant who has served IOA in capacity of Organising Secretary of IOACON or Chairman of IOACON is not eligible to contest in Election year of the scheduled and subsequent year of the said conference. For example, those who have organised IOACON in 2024, can contest for IOA Election 2026 and subsequent.
- c. Applicant who has not served IOA for at least one term as member of Executive Committee, is not eligible to contest for the post of Vice President.

Vii Please note, one member can contest for One post only as per norms of IOA.

CODE OF CONDUCT

INDIAN ORTHOPAEDIC ASSOCIATION (IOA) ELECTIONS: 2024

- 1. Duration of Code of Conduct is from the date of notification of the Elections till the declaration of results.**
- 2. Any Life member of the IOA shall be permitted to contest for any post of the IOA only after completion of 5 years of his/her life membership with IOA.**
- 3. If any candidate writes derogatory or defamatory remarks via emails/ WhatsApp or on any other social media, against the Association or any of its members, the same may result in the disqualification from the election process along with necessary disciplinary action that would be taken against such candidate and the membership such candidate may be suspended.**
- 4. In case any contestant or his representative or assignee is found/ proved to have used unfair means (including approaching candidates with laptops or to coerce them in any other way, ask them to vote for any particular candidate openly or infringing on anyone's privacy, attempting to cast illegitimate vote, usurp identity of any other voter to cast vote on his behalf or indulge in manipulation of any kind) his candidature shall be liable to be cancelled and he may be debarred from contesting for any post in IOA for the next 5 years.**
- 5. Any member indulging in anti-association/anti-national activities and/or smearing its image in public will not be eligible to apply for a constitutional/organizational post in the very organization. Any member who indulges in these nefarious activities may be recommended to be suspended/debarred from the IOA.**
- 6. Any Life member is permitted to contest for a particular post only thrice (3 times).**
- 7. Any Life member is permitted to contest for one post only in a particular election. .**
- 8. Code of Conduct is also applicable to the IOACON bidding state chapter and Dr. K. T. Dholkia CME bidding state chapter.**
- 9. It is mandatory to submit signed code of conduct by a contestant/bidder along with the nomination form**
