Minutes of the Sixth Meeting of the Committee for 2024-2025 IOA Elections

1. Thirty-two representations have been received from various Members of IOA from 22nd November, 2025 to 24th November, 2025 seeking modification of the Schedule of IOA 2025 Election to the extent that the date of scrutiny of the nomination forms be preponed from 27th November, 2025 and the list eligible members be declared after scrutiny before the date of withdrawal.
2. Dr. Navin Thakkar and Dr. Rajeev Raman, Ld. Convenors, who are also the office bearers of the Central Committee, submit that IOA has no objection to the modification of the Election Schedule. Dr. Anil Jain, Ld. Member of this Election Committee agrees with the proposal for modification. Dr. Rajesh Malhotra also agrees to the proposed modification of the Election Schedule. Mr. Sumit Chander, Returning Officer also approves the modification of the Election Schedule.

3. The undersigned is satisfied that the modification of the Election Schedule sought by the Members is necessary and therefore, the IOA 2025 Election Schedule is modified. The modified Schedule of IOA 2025 Election is as under: -

Start of online voting by CDSL	3 rd December, 2025 – 10:00 AM
Closure of online voting by CDSL	13 th December, 2025 – 05:00 PM
Counting & Result declaration Venue: Online vide platform	13 th December, 2025 – 05:30 PM onwards online declaration of result

4. The Ld. Secretary General shall issue the modified Election Schedule of IOA 2025 Election on IOA website.

5. The contestants are advised to remain available on the telephone around the meeting time i.e. on 25th November, 2025 at 08:00 PM, they may be asked to join the meeting, if so required.
